CALL TO ORDER

Board chair Steve McGowan called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:38 PM, Tuesday, February 28, 2017 at the Foundation's Monterey office.

CONSENT AGENDA – Steve McGowan

Steve McGowan asked the board if they had any questions or required clarification on matters related to the consent agenda. There were no questions or concerns.

Motion: to approve the Consent Agenda. Rick Kennifer / Birt Johnson, Jr. second. Motion carried unanimously.

REPORT OF THE CHAIR – Steve McGowan

Steve McGowan reported on the Legacy Society Luncheon held February 22, 2017 at the Monterey Plaza Hotel. There were 145 attendees including seven board members. The event was well organized and the speakers Hanson Reed and Dr. James Valentine were successful in delivering a strong message for the power of endowments. It was suggested that special name tags be made for board members, so guests can know who they are.

INVESTMENT COMMITTEE – Dan Baldwin for Ken Petersen

Dan Baldwin reviewed the Pooled Endowment Portfolio Overview for the period ending 12/31/16. He summarized the asset allocation and the preliminary portfolio returns for 2017. Ken Petersen will describe the role of the Investment Policy at the April Board meeting.

RESOURCE DEVELOPMENT – Betsy Buchalter Adler

The next Resource Development Committee meeting will be March 16, 2017.

Betsy Buchalter Adler and Christine Dawson reported on the December and January Resource Development Summaries.

Christine announced the Women's Fund Luncheon is Tuesday, May 9, 2017 at the Monterey Hyatt. The keynote speaker will be Tracy Gary, author of *Inspired Philanthropy*. Her latest venture is the Tipping Point Fund for which she is raising \$20 million to shift poverty and the environment. The luncheon will also feature GHGH scholarship recipients.

Dan Baldwin highlighted two slides from the presentation shown at the Legacy Luncheon. Dan described *Future Legacy Gifts for Donor Advised Funds* and *Future Legacy Gifts by Fund Type*, and how they work in the CFMC's development plan.

TREASURER'S REPORT- Teri Belli

As part of a new reporting style for 2017 board meetings, Teri will do short educational presentations about current finance committee topics and financial statements, instead of reading summaries sent in the board packets.

Teri produced presentation on *How to Read CFMC Financial Statements*. She highlighted specific line items that are important to the annual operations of the CFMC. She summarized the *Combined Operating Fund Budget vs. Actual* spreadsheet and the Statement of Financial Position.

Motion: to approve the December 30, 2016 and January 31, 2017 Financials. Ida Lopez Chan \ Anna Marie Ponce second. Motion carried unanimously.

AUDIT COMMITTEE UPDATE – Steve McGowan for Tina Starkey Lopez

Steve reported the new audit firm, Hutchinson and Bloodgood LLP, has completed their field work and will have a preliminary draft to the CFMC management April 3, 2017. The next Audit Committee meeting is April 18, 2017.

GRANTS AND PROGRAMS – Patti Hiramoto

Patti Hiramoto reported the Grants and Programs Committee met February 8 and discussed the impact of CFMC's recent growth on grantmaking. The committee will be taking a high-level look at the impact of grants and programs in 2016 and 2017. They will further define the Community Impact goals outlined in the CFMC's Strategic Plan. The committee will continue to discuss the 5-year consecutive funding limitation for Community Impact grantees.

The 2016 spring cycle for Community Impact Grants received 61 applications requesting a total of \$2,099,522.

The small grant applications are due March 3.

Motion: to approve 245 grants awarded from December 1, 2016 through January 31, 2017, totaling \$2,184,301. Betsy Buchalter Adler / Birt Johnson, Jr., second. Motion carried unanimously.

GOVERNANCE COMMITTEE – Dan Baldwin for Greg Chilton

Dan reported the Governance Committee is in the process of nominating three new board members for the 2017 board. This will bring the board member total to 21. Dan described the three people the committee is recommending to join the board in the first quarter of 2017. The full board will vote by email to elect nominees and the new members will attend the April 25 board meeting. Any board members with comments or concerns not stated at the meeting will contact Dan or Greg.

NEW FUNDS – Dan Baldwin

Dan Baldwin reported there is a new fund being initiated by the local hospitality sector call the Big Sur Relief Fund. It will have a different intent than the Soberanes Fire Fund and will most likely be distributed through the Coastal Property Owners Association, a nonprofit in Big Sur.

PRESIDENT’S REPORT – Dan Baldwin

Dan reviewed the non-portfolio assets which include promissory notes receivable, bequests receivable, Charitable Remainder Trusts (CRTs) Charitable Gift Annuities (CGAs), real estate, and oil and gas rights. There was a discussion about the unique stories behind these assets.

Dan led a discussion about the Soberanes Fire Fund and how this winter’s storms have impacted Big Sur far beyond the fire zone. CFMC has intentionally held back funds for the recovery portion of the fire and approximately \$350,000 remains in the fund. The people of Big Sur are dealing with a lot of challenging situations with weather events and road failures. Dan recommended to the board that CFMC broaden the vision of how to deploy the fund’s remaining assets. It will remain a Big Sur fund, but the needs are being assessed by CFMC staff and the CPOA board of directors.

Dan reported on the current events and circumstances that involve the Dan and Lillian King Foundation. A board working group (Rick Kennifer, Betsy Buchalter Adler, Greg Chilton, and Dan Baldwin) has been working with the CFMC’s attorney, Chris Campbell, to draft a set of conditions to present to the King Foundation to resolve the conflict. The King Foundation has appealed the September 14 ruling that ruled in the CFMC’s favor.

The board went into Executive Session at 5:50 PM.

CALL TO ORDER – Steve McGowan

Steve McGowan called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:30 PM, Tuesday, March 28, 2017 at the Foundation's Salinas office.

APPROVAL OF MINUTES

Motion: to approve the November 22, 2016 minutes:

Ken Wright / Greg Chilton second. Motion carried unanimously.

REPORT OF THE CHAIR - Steve McGowan

Steve asked for observations on the Community Foundation Fundamentals course that Bill Sharpe, Ken Petersen, Betsy Buchalter Adler and Birt Johnson, Jr. attended in March. Phil Carey attended from the CFMC staff. The board members felt it was well worth their time, useful to learn from peers and provided new information on the community foundation field.

Christine Dawson described the Women's Fund Luncheon scheduled for May 9. Tracy Gary is the keynote speaker and author of *Inspired Philanthropy*. Tracy will hold a workshop at the CFMC on May 10 for Professional Advisors. Christine encouraged the board and guests to attend the luncheon.

Dan Baldwin provided a reminder on certain meeting protocols. There is some flexibility based on the current chair's style, but there are common rules and best practices for how the full board can operate in a meeting.

- The chair recognizes the member
- The member makes the motion
- Another member seconds the motion
- The chair states the motion: *It is moved and seconded that...*
 - Members can discuss the motion.
 - The chair asks for a vote

INVESTMENT COMMITTEE - Ken Petersen

Ken Petersen reported the Investment Committee will meet May 8. Ken handed out summaries for the Long Term, Medium Term and ESG portfolios.

The goals for the Investment Committee in 2017 are:

- Work as good fiduciaries following an established work plan
- Conduct quarterly performance review in accordance with the Investment Policy Statement
- Review socially responsible investing options
- Review the asset allocation
- Review the Investment Policy Statement and asset manager performance
- Educate the board on specific investment strategies
- Designate the 2018 spend rate

RESOURCE DEVELOPMENT COMMITTEE - Betsy Buchalter Adler

Betsy reported the first Resource Development meeting for 2017 will be April 20. Betsy discussed the need to add two more members to the Resource Development Committee and recommended people with wealth management experience, attorneys and professional advisors. Christine Dawson commented that attorney Hansen Reed has been asked and accepted an offer to join the committee. Ken Petersen volunteered to join the committee.

The Executive Committee discussed the importance of committee chairs reporting back to the Governance Committee when committee members with specific skill sets are needed. They keep a list of potential candidates and interested community members.

Three goals for Resource Development 2017 include:

- Development of the Latino Philanthropy Initiative
- Growing family philanthropy
- Educating the community about philanthropy

TREASURERS REPORT- Teri Belli

Teri requested a change in the procedure for the presentation of financial statements in the Executive Committee meetings. The statements will be included in the committee packets, but since they have not been reviewed by the Finance Committee they will not be approved by the Executive Committee. If there are important issues in the statements they will be addressed, but otherwise the financial statements will be approved at the full board meetings after review by the Finance Committee. The Executive Committee agreed with the procedural change.

Teri requested two more members for the Finance Committee and recommended bankers or other finance oriented members. Dan and the Governance Committee will seek people to expand the Finance Committee's strength.

The goals for the Finance Committee 2017 include:

- Educating the board on the financial reports
- Looking at streamlining the internal financial report process
- Review the building reserve and what is the proper amount to hold
- Recruit more finance committee members

GRANTS AND PROGRAMS COMMITTEE – Patti Hiramoto

Patti Hiramoto reported on the goals for the Grants and Programs Committee.

1. The committee will look at the continuing growth of the CFMC and assess if the grantmaking and community impact are in alignment. They will determine whether existing programs are the right size and if the amount of work equals the value of the program.

2. Define the Community Impact Funding Limit
Patti reviewed the history behind the recommendation to eliminate the five-year consecutive funding limit for Community Impact (CI) grantees, that was presented at the August 23, 2016 Board meeting. The committee will bring a recommendation to the May Executive Committee meeting and ask for a vote at the August board meeting.

Patti reported there is a grant recommendation for approval by the Executive Committee. The grant is:

- Fund: The Buffett Fund
- Agency: Oregon Shakespeare Festival
- Amount: \$100,000
- Purpose: the production of Othello to be performed in 2018

Motion: to approve the \$100,000 grant from the Buffett Fund for the 2018 Oregon Shakespeare Festival performance of Othello.

Patti Hiramoto / Ken Wright second. Motion carried unanimously.

GOVERNANCE COMMITTEE – Greg Chilton

Greg Chilton reported the CFMC board will have four board members stepping down at the end of 2017. The committee will start the nominating process by mid-year to select candidates to start in 2018. There are seven seats available.

In the meantime, two new board member nominees, Nolan Kennedy and Fred Meurer, have accepted joining the board and the board will vote by email to elect them. If elected they will attend the April 25, 2017 board meeting.

NEW FUND APPROVALS - Dan Baldwin

Dan Baldwin described the new funds approved since the last meeting.

- Joel and Dena Gambord Nursing Scholarship Fund
- All Saints' Day School Endowment Fund
- Drezner Family Scholarship Fund
- Neidel Family Fund
- Shelley Family Fund
- Cambrel B. Marshall Fund

PRESIDENTS/CEO REPORT - Dan Baldwin

Dan announced that Josh Warburg has accepted the position of Program and Scholarships Officer. For the time being, he will continue to perform his duties in Philanthropic Services and work with Janet Shing in support of the CI grant cycle. The Philanthropic Services Department will advertise a position for a Philanthropic Services Associate. There is an internal workgroup doing an assessment of the workflow and conducting a series of interviews with staff based on the growth of CFMC in 2016/2017.

The King Foundation

Dan reported the next hearing for the Dan and Lillian King Foundation is May 17. The King Foundation attorney has told CFMC counsel that he agrees with our position. However, this has not been conveyed to his clients. There is an April 6 deadline for the King Foundation to act on their appeal of the September 14, 2016 ruling for a final report on the King Foundation accounting. They have indicated they will let the deadline pass.

Joel Gambord/ CSUMB

Dan described the sequence of events that lead current CFMC donor advisor, Joel Gambord, to ask the CFMC to act as the steward of his bequest to CSUMB after his death. The bequest includes a large fund dedicated to nursing scholarships.

Executive Session

Steve McGowan asked for a short executive session.

The meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Teri Belli at 2:00PM on February 28, 2017.

Minutes

Teri Belli asked if there were any changes or corrections to the minutes; there were none. The minutes will stand approved as written.

Financial Statement Review

Teri Belli reviewed the complete financial statement for December 2016.

Teri then reviewed the complete financial statement for January 2017.

The committee discussed the format of the complete financial statement vs. the condensed financial statement, sent to the board. Teri stated the board should continue to receive the condensed statements; however, it should include the complete financial statement notes.

Assets

Total Assets through 2/28/2017 are **\$211,693,529** a **23.19%** increase since February 2016, and a **1.14%** increase since December 2016.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2016.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$94, and unrealized gains were \$5,946,393, for a total gain of \$5,946,299.

Operating Fund

Total revenue was \$10,851 more than the budget, and total expenses were \$31,339 less than the budget. The actual net operating deficit is \$428,408 compared to a budgeted deficit of \$470,599.

Note: The Expendable Operating Cash-on-Hand is at 3.9 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 2/28/2017 was \$169,343,266. The year-to-date Total Return for the Long-Term Endowment Portfolio through February 28, 2017 was 3.5% compared to the Policy Index of 3.7%.

The market value of the Medium-Term Fund portfolio at 2/28/2017 was \$1,926,414. The year-to-date Total Return for the Medium-Term Portfolio through February 28, 2017 was 2.5% compared to the Policy Index of 2.5%.

The market value of the ESG Fund portfolio at 2/28/2017 was \$896,726. The year-to-date Total Return for the ESG Fund Portfolio through February 28, 2017 was 3.2% compared to the Policy Index of 3.2%.

Special Program Funds

Special Program Funds include: Community Leadership Project, funded by the David and Lucile Packard Foundation; Pathways to Safety, funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; and the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; and the College Futures Foundation program, funded by the College Futures Foundation.

Total Special Program revenue was \$47,428 and total expenses were \$100,960.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$91,738, including \$40,000 from the Colleagues of the Arts for the Colleagues of the Arts Endowment Fund.

Grants to agencies for the month totaling \$3,927,983 were approved and recorded. A complete list of the grants by grantee is included.

Interfund activity for the month totaled \$291,696.

Assets

Total Assets through 3/31/2017 are **\$210,907,381** an **18.60%** increase since March 2016, and a **0.76%** increase since December 2016.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2016.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$129, and unrealized gains were \$6,491,828, for a total gain of \$6,491,699.

Operating Fund

Total revenue was \$32,043 less than the budget, and total expenses were \$56,816 less than the budget. The actual net operating deficit is \$42,052 compared to a budgeted deficit of \$64,825.

Note: The Expendable Operating Cash-on-Hand is at 5.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 3/31/2017 was \$168,286,008. The year-to-date Total Return for the Long-Term Endowment Portfolio through March 31, 2017 was 4.3% compared to the Policy Index of 4.0%.

The market value of the Medium-Term Fund portfolio at 3/31/2017 was \$1,935,263. The year-to-date Total Return for the Medium-Term Portfolio through March 31, 2017 was 3.1% compared to the Policy Index of 2.9%.

The market value of the ESG Fund portfolio at 3/31/2017 was \$900,408. The year-to-date Total Return for the ESG Fund Portfolio through March 31, 2017 was 4.0% compared to the Policy Index of 4.1%.

Special Program Funds

Special Program Funds include: Community Leadership Project, funded by the David and Lucile Packard Foundation; Pathways to Safety, funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; College Futures, funded by the College Futures Foundation Fund; and the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; and the College Futures Foundation program, funded by the College Futures Foundation.

Total Special Program revenue was \$47,485 and total expenses were \$118,465.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants (p. 21-23)

Total new contributions for the month were \$463,407, including \$50,000 from the Schneider Family Fund at Vanguard Charitable to establish the Drezner Family Scholarship Fund and \$50,000 from the Carmel Heritage Society to establish the Carmel Heritage Society Stewardship Fund.

Grants to agencies for the month totaling \$1,998,572 were approved and recorded. A complete list of the grants by grantee is included.

Interfund activity for the month totaled \$122,000.

Contribution/Bequest Receivables

We received \$42,637 from the termination of the Paul Lawrence Charitable Gift Annuity, for the Women's Fund Endowment.
