NOTES TO THE FINANCIAL STATEMENTS  
For the Three Months Ended March 31, 2017**

**Assets**

Total Assets through 3/31/2017 are **\$210,907,381** an **18.60%** increase since March 2016, and a **0.76%** increase since December 2016. **(p. 3)**

**Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)**

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2016. **(p. 3)**

**Realized and Unrealized Gains and Losses on Investments**

Net year-to-date realized losses were \$129, and unrealized gains were \$6,491,828, for a total gain of \$6,491,699. **(p. 6)**

**Operating Fund**

Total revenue was \$32,043 less than the budget, and total expenses were \$56,816 less than the budget. The actual net operating deficit is \$42,052 compared to a budgeted deficit of \$64,825. **(p. 7)**

Note: The Expendable Operating Cash-on-Hand is at 5.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000. **(p. 8)**

**Portfolio Performance**

The market value of the Long-Term Fund portfolio at 3/31/2017 was \$168,286,008. The year-to-date Total Return for the Long-Term Endowment Portfolio through March 31, 2017 was 4.3% compared to the Policy Index of 4.0%. **(p. 9-12)**

The market value of the Medium-Term Fund portfolio at 3/31/2017 was \$1,935,263. The year-to-date Total Return for the Medium-Term Portfolio through March 31, 2017 was 3.1% compared to the Policy Index of 2.9%. **(p. 13-14)**

The market value of the ESG Fund portfolio at 3/31/2017 was \$900,408. The year-to-date Total Return for the ESG Fund Portfolio through March 31, 2017 was 4.0% compared to the Policy Index of 4.1%. **(p. 15-16)**

**Special Program Funds**

Special Program Funds include: Community Leadership Project, funded by the David and Lucile Packard Foundation; Pathways to Safety, funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; College Futures, funded by the College Futures Foundation Fund; and the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; and the College Futures Foundation program, funded by the College Futures Foundation.

Total Special Program revenue was \$47,485 and total expenses were \$118,465. **(p. 5-6)**

**Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants (p. 21-23)**

Total new contributions for the month were \$463,407, including \$50,000 from the Schneider Family Fund at Vanguard Charitable to establish the Drezner Family Scholarship Fund and \$50,000 from the Carmel Heritage Society to establish the Carmel Heritage Society Stewardship Fund. **(p. 33-44)**

Grants to agencies for the month totaling \$1,998,572 were approved and recorded. A complete list of the grants by grantee is included. **(p. 45-50)**

Interfund activity for the month totaled \$122,000. **(p. 44 & 50)**

**Contribution/Bequest Receivables**

We received \$42,637 from the termination of the Paul Lawrence Charitable Gift Annuity, for the Women's Fund Endowment. **(p. 44)**






