**CALL TO ORDER**

Board chair Steve McGowan called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:35 PM, Tuesday, August 22, 2017 at the Foundation's Monterey office.

**REPORT OF THE CHAIR – Steve McGowan**

Steve reported the 2017 Celebration of Philanthropy will be October 25 at Corral de Tierra County Club. David and Susan Gill from King City have agreed to receive the Distinguished Trustee Award and will be honored at the Celebration of Philanthropy.

Steve announced a change in the agenda and asked the Grants and Programs committee to present their items after the report of the chair.

**GRANTS AND PROGRAMS – Patti Hiramoto  
Grant Recommendations and Approvals**

Patti Hiramoto reviewed the grant recommendations since the last board report.

The grant report to ratify is from June 1, 2017 – July 31, 2017. The Community Foundation awarded 339 grants totaling \$ 3,068,081.

**Motion: To approve the 339 grant awards from June 1, 2017 – July 31, 2017 totaling \$3,068,081. Birt Johnson, Jr./ Ken Wright second. Motion carried unanimously.**

Patti presented two grants over \$50,000 for approval not on the agenda.

Birt Johnson, Jr./ Ida Lopez Chan second. Motion carried unanimously.**

#### **Community Impact Consecutive Year Funding Limit**

Patti Hiramoto and Birt Johnson, Jr. reviewed the history behind the recommendation to eliminate the five-year consecutive funding limit for Community Impact (CI) grantees. The information was originally presented at the August 23, 2016 board meeting. A one-year extension of the funding limit was approved in 2016. The Grants and Programs Committee is asking the board to approve the elimination of the five-year funding limit.

After a discussion by the Board regarding why there was a funding limit established in the Community Impact Guidelines in 2012, a decision was reached to eliminate the five-year funding limit.

**Motion: to eliminate the five-year consecutive funding limit guideline established in 2012 for Community Impact Grants.**

#### **INVESTMENT COMMITTEE – Ken Petersen**

Ken Petersen reported on the current positions of the Long Term, Medium Term and ESG portfolios. The next investment committee meeting on November 13 will review the 2018 spending policy.

#### **RESOURCE DEVELOPMENT – Betsy Buchalter Adler**

Betsy Buchalter Adler reported on the July 2017 Development Summary of Activities. Betsy noted the power of relationship building that is reflected in the success of the philanthropic services offered by CFMC.

Christine Dawson reported on the upcoming September 15 Philanthropy Education Series, with presenter Anne Westreich, CFA, from Verus. Betsy Buchalter Adler will have a Donor Education workshop on Family Philanthropy in November.

The MC Gives! campaign will hold an information session at the CSUMB World Theater.

#### **TREASURER’S REPORT- Teri Belli**

Teri Belli reviewed and compared some specific areas of the June and July Financial Statements. After a thorough discussion about the different line items there was a motion to approve the June and July financials.

The 2016 990 tax form is complete and has been on the board portal for review. The Finance Committee recommends the 990 be approved.

### **Budget update**

The 2018 budget process will be in round three at the October 24 Finance Committee meeting. A special meeting will be held in November to finalize the 2018 budget to present at the December board meeting.

### **GOVERNANCE COMMITTEE – Greg Chilton**

Greg Chilton reported on the August 7 Nominating Committee meeting. The committee identified the skills and geographic areas of interest for the 2018 board recruitment. This includes accounting, agriculture, law enforcement, and estate planning with consideration for gender, diversity and geography.

The governance committee will bring recommendations for new board members to the October board meeting.

## **PRESIDENT'S REPORT – Dan Baldwin**

### **King Foundation Settlement**

Dan reported on the successful outcome of the negotiations which led to the final settlement with the Dan and Lillian King Foundation. Dan outlined the stipulations that were agreed upon by both parties and accepted by the court. Dan described the agreement as a very positive result for the CFMC.

### **Wolf CGA Update**

In a PowerPoint presentation, Dan outlined the financial structure of the Marty Wolf, CGA.

### **James and Barbara Miller Charitable Remainder Annuity Trust**

Dan reported on a new Charitable Remainder Annuity Trust that requires the CFMC to act as an “administrative agent” until the court approves the amendment needed for CFMC to be the “trustee.” This agreement does require approval by the Board.

**Motion: 1. to authorize the President / CEO of the CFMC to act as the administrative agent for the James and Barbara Miller Charitable Remainder Annuity Trust.**

**2. To approve the CFMC to act as the trustee of the James and Barbara Miller Charitable Remainder Annuity Trust, once the amendment to the trust is approved by the court.**

**Betsy Buchalter Adler / Ken Wright second. Motion carried unanimously.**

### **de Guigne Planned Gift**

Dan updated the Board on the circumstances of the de Guigne Planned Gift. Because of the size of the gift the CFMC will re-establish the Real Estate Committee to advise on the future sale of the real estate involved. Jim Heisenger and John Mahoney were suggested as non-board members and Greg Chilton, Bill Mitchell, Ken Petersen, and Nolan Kennedy volunteered from the board.

A Real Estate Committee meeting will be set up soon to outline the guidelines on how to proceed.

### **Impact Investing**

Dan led a discussion on how the CFMC can move forward with Impact Investing. He presented the results of his research and community outreach. The Board agreed to create an Impact Investing committee to get more specific on the CFMC role and further study the impact and risk factors.

The board went into Executive Session at 5:30 PM.

Steve McGowan called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:35 PM, Tuesday, September 26, 2017 at the Foundation's Monterey office.

### **APPROVAL OF MINUTES**

**Motion: to approve the July 25, 2017 minutes:**

### **de Guigne Estate Gift**

Steve McGowan introduced CFMC board member Rick Kennifer, attorney from Johnson, Fantl & Kennifer, representing the de Guigne Estate.

Rick described the details of the de Guigne Gift which includes a six-acre waterfront property in Pebble Beach and other liquid assets. Rick brought the committee up to date and described the delays from Wells Fargo Bank to accept the trusteeship. Any action to move forward on the de Guigne bequest is at a standstill until Wells Fargo Bank accepts the role of trustee. Wells Fargo has concerns that there is not enough liquidity to pay direct bequests

After a thorough discussion, the Executive Committee decided there is not enough information from Wells Fargo about what is actually needed and directed Rick to inform Wells Fargo the CFMC would not loan funds to pay the direct bequests.

**Motion: to approve the decision that the Community Foundation for Monterey County is not willing, at this time, to advance money to payout the shortfall to the beneficiaries named in the de Guigne bequest.**

### **RESOURCE DEVELOPMENT COMMITTEE - Betsy Buchalter Adler – Call in**

Betsy Buchalter Adler highlighted activities in the August Resource Development Summary. Christine Dawson spoke about the August 30 meeting where the gift acceptance policy was discussed. Christine noted the success of the recent donor education series and described the upcoming campaign for Monterey County Gives!.

The 2018 board officers were selected and both the nominations to the board and officers will be confirmed at the October board meeting.

**Discussion**

1. Discuss Neighborhood Grants Program (NGP) Assessment

Laurel Lee-Alexander and Janet Shing provided background information and clarified the purpose of the assessment of the CFMC’s Neighborhood Grants Program (NGP). Aurelio Salazar, Jr. presented the current process and proposed revisions for efficiency. Board members shared the following comments:

- The program changes show great improvement and progress.
- NGP provides another entry point for grant applicants and augments CFMC’s grantmaking program. This early investment in the grassroots community pays off in the long-term.
- The Opportunity and Small Community Impact grant programs are staff-led. Since these programs award grants in higher amounts than NGP, is it necessary to have a Board member involved in the process?
- Encouragement to continue shortening the decision process to allow grantees to receive grants earlier and focus on their community work.

**Assets**

Total Assets through 8/31/2017 are **\$224,315,872** an **18.14%** increase since August 2016, and a **7.16%** increase since December 2016.

**Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)**

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2016, plus new 2017 additions. In August Marc Rosen added \$91,500 to his CRT, with a remainder value of \$10,607; and Robert Haas established his sixth CGA, valued at \$55,000, with a remainder value of \$20,151.

**Realized and Unrealized Gains and Losses on Investments**

Net year-to-date realized gains were \$7,114, and unrealized gains were \$14,618,075, for a total gain of \$14,625,189.

**Operating Fund**

Total revenue was \$7,449 less than the budget, total expenses were \$38,131 less than the budget, the realized gains were \$335 and unrealized gains were \$29,310 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$444,126 compared to a budgeted deficit of \$504,454.

Note: The Expendable Operating Cash-on-Hand is at 3.9 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

**Portfolio Performance**

The market value of the Long-Term Fund portfolio at 8/31/2017 was \$177,859,188. The year-to-date Total Return for the Long-Term Endowment Portfolio through August 31, 2017 was 10.0% compared to the Policy Index of 9.4%.

The market value of the Medium-Term Fund portfolio at 8/31/2017 was \$4,323,854. The year-to-date Total Return for the Medium-Term Fund Portfolio through August 31, 2017 was 7.3% compared to the Policy Index of 7.2%.

The market value of the ESG Fund portfolio at 8/31/2017 was \$990,907. The year-to-date Total Return for the ESG Fund Portfolio through August 31, 2017 was 9.5% compared to the Policy Index of 9.5%.

**Special Program Funds**

Special Program Funds include: Community Leadership Project, funded by the David and Lucile Packard Foundation; Pathways to Safety, funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; and the College Futures Foundation program, funded by the College Futures Foundation.

Total Special Program revenue was \$593,654 and total expenses were \$660,868.

**Assets**

Total Assets through 9/30/2017 are **\$227,012,451** a **16.45%** increase since September 2016, and an **8.45%** increase since December 2016.

**Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)**

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2016, plus new 2017 additions. In September a CRT was established by the estate of Evelyn V. Torras, in the amount of \$600,000, for the benefit of her two brothers, Dareld and Richard Harris, with a remainder value of \$44,385.

**Realized and Unrealized Gains and Losses on Investments**

Net year-to-date realized gains were \$8,566, and unrealized gains were \$16,208,208, for a total gain of \$16,216,774.

**Operating Fund**

Total revenue was \$17,688 less than the budget, total expenses were \$55,673 less than the budget, the realized gains were \$335 and unrealized gains were \$30,426 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$11,940 compared to a budgeted deficit of \$80,686.

Note: The Expendable Operating Cash-on-Hand is at 5.8 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

**Portfolio Performance**

The market value of the Long-Term Fund portfolio at 9/30/2017 was \$179,530,266. The year-to-date Total Return for the Long-Term Endowment Portfolio through September 30, 2017 was 11.4% compared to the Policy Index of 10.6%.

The market value of the Medium-Term Fund portfolio at 9/30/2017 was \$4,440,284. The year-to-date Total Return for the Medium-Term Fund Portfolio through September 30, 2017 was 7.9% compared to the Policy Index of 7.8%.

The market value of the ESG Fund portfolio at 9/30/2017 was \$1,000,345. The year-to-date Total Return for the ESG Fund Portfolio through September 30, 2017 was 10.8% compared to the Policy Index of 11.0 %.

**Special Program Funds**

Special Program Funds include: Community Leadership Project, funded by the David and Lucile Packard Foundation; Pathways to Safety, funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; and the College Futures Foundation program, funded by the College Futures Foundation.

Total Special Program revenue was \$593,720 and total expenses were \$775,380.
