CALL TO ORDER

Board chair Birt Johnson, Jr., called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:35 PM, Tuesday, February 26, 2019 at the Foundation's Monterey office. He welcomed Elsa Mendoza Jimenez, Jose Luis Alvarado and Giff Lehman to their first meeting.

CONSENT AGENDA – Birt Johnson, Jr.

Birt Johnson, Jr., asked the board if they had any questions or required clarification on matters related to the consent agenda. There were no questions or concerns..

Motion: to approve the Consent Agenda as presented. Loren Steck / Fred Meurer second. Motion carried unanimously.

REPORT OF THE CHAIR – Birt Johnson, Jr.

Birt Johnson reported on the Legacy Society Luncheon held February 5, 2019 at the Monterey Plaza Hotel. He noted there was a lot of positive feedback from attendees. Birt thanked the board for their strong attendance and complimented the speaker, Marty Wolf, for delivering an engaging message about the influence his family had on his philanthropic outlook.

Birt also noted the annual Women's Fund Luncheon is on May 16 at the Hyatt Hotel with keynote speaker, Julie Castro Abrams; he encouraged everyone to attend.

Birt recognized the new committee chairs for 2019: Ken Petersen for Investment, Jan Vanderbilt (Teri Belli will assist) for Finance, Jeff Eikenberry for Audit, Ida Lopez Chan for Grants and Programs and Michael Reid for Resource Development.

INVESTMENT COMMITTEE – Ken Petersen

Ken Petersen gave a presentation to the board of the 1/31/19 portfolio overview and market value of the long-term fund, medium-term fund, and the ESG funds. He summarized the role of the investment committee through good stewardship and fiduciary responsibilities. Ken described how the committee members interact with the portfolio manager, Anne Westrich of Verus, and praised the collective knowledge the committee members bring to the CFMC. Ken shared the example of Bill Sharpe, featured on the cover of the current Investor magazine.

Ken stressed the importance of managing expectations and showed examples of returns and declines over 30 years of the S&P 500 market. He highlighted why CFMC needs an investment policy statement with the guiding principles and responsibilities for good governance. The committee is reviewing the Investment Policy Statement created in 2012 and will bring any policy changes to the April board meeting.

COMMUNITY IMPACT INVESTING – Nolan Kennedy

Nolan Kennedy reported the first two approved community impact investment loans have been implemented; \$1 million to The Opportunity Fund and \$375,000 of \$750,000 to California Farmlink.

The committee recommended revisions to the Community Impact Investment (CII) Policy Statement created April 2, 2018. The changes were posted on the board portal for review prior to the meeting. Nolan discussed the changes in each area and recommended approval of the revisions.

- Changes to Addendum to Investment Police Statement:
 Motion: to approve the revised 2018 Investment Policy Addendum.

RESOURCE DEVELOPMENT – Michael Reid

Michael Reid reported the committee has not met in 2019, but they have created a template for the outlook and goals for the year.

Christine Dawson reported on the December and January Resource Development Summaries. 2018 highlights include:

- New funds created: 38
- Legacy Society to-date: 226
- Total contributions that began new funds: \$5,773,325.33
- Monterey County Gives! 2018 raised over \$5,500,000. The 2018 grants were presented to the participating non-profits on February 21.

Christine Dawson announced upcoming events:

- Donor Education event March 7, 2019, "Design Your Philanthropic Vision" with Christine Dawson
- The Women's Fund Luncheon is Thursday, May 16, 2019 at the Hyatt Regency Monterey. The keynote speaker will be Julie Castro Abrams, an experienced CEO and sought-after speaker in entrepreneurship and how women lead.
- The Professional Advisor Council is organizing a lunch for early May.

TREASURER/FINANCE COMMITTEE - Teri Belli for Jan Vanderbilt

Teri Belli reviewed the Notes to the Financial Statements for the 12 months ending 12/30/2018. She described the key areas for the new board members to be aware of. She reviewed total assets, realized and unrealized gains and the operating fund. In the January 31, 2019 statement, Teri described the operating reserve, cash on hand and building reserve.

Motion: to approve the December 30, 2018 financial statements. Ken Petersen / Ida Lopez Chan, second. Motion carried unanimously.

Motion: to approve the January 31, 2019 financial statements. Ken Petersen / Maija West, second. Motion carried unanimously.

AUDIT COMMITTEE UPDATE – Diane Nonella for Jeff Eikenberry

Diane Nonella reported the audit firm, Hutchinson and Bloodgood LLP, has completed their field work. The audit will be presented at the April Board meeting.

GRANTS AND PROGRAMS – Ida Lopez Chan

Ida Lopez Chan thanked the committee members working on the 2019 Community Impact (CI) spring cycle sub committees. Ida recommended approval of the December1, 2018-January 31, 2019 grants.

Motion: to approve 383 grants awarded from December 1, 2018 through January 31, 2019, totaling \$2,621,682. Lorne Steck/Betsy Buchalter Adler, second. Motion carried unanimously.

Laurel Lee-Alexander requested approval for the 2019 Fund Allocations for CFMC Grant Programs. She described the beginning balance of the Unrestricted (which includes the General Endowment) and Field of Interest (FOI) funds available for grantmaking is: \$2,528,832

- Available from FOI funds: \$1,934,145
- Available from Unrestricted funds (including \$340,419 from the General Endowment): \$594,687

After the following disbursements are allocated from the Unrestricted funds, \$2,383,201.50 is available for Community Impact (CI) grantmaking.

- \$10,693.10 for the Opportunity Fund (plus \$139,306.90 carryover from 2018):
 - \$100,000 for Opportunity and Organizational Development grants to support small grants (typically less than \$5,000) for organizational development, emerging ventures and urgent needs.
 - \$50,000 for CEO Discretionary Grants for CFMC grants to support time-sensitive needs
- \$49,937.41 to the Neighborhood Grants Program (plus carryover from 2018 = \$50,000 for grantmaking) – for small grants to grassroots, mostly voluntary associations of neighborhood residents coming together around community improvement efforts.
- \$50,000 to support Monterey Bay Economic Partnership's program expansion for affordable housing research and planning (second year of a three-year commitment).

- \$15,500 for various grants (MC Gives! awards and match: \$14,500; Philanthropy Day awards: \$1,000).
- \$10,000 for the Distinguished Trustee Award for designated grant to an organization to be chosen by the Community Foundation's 2017 Distinguished Trustee.
- \$9,500 for CFMC Employee Matching Gift program (\$500 allocated for each of 19 employees).

Motion: to approve the proposed 2019 allocations of \$100,000 from General Endowment (GEN) to the Opportunity Fund, \$50,000 for the CEO Discretionary Grants Program (for CFMC grants to support time-sensitive needs),\$49,937.41 from GEN to the Neighborhood Grants Program, \$50,000 to support Monterey Bay Economic Partnership, \$15,500 for various grants (MC Gives! awards and match:\$14,500; Philanthropy Day awards: \$1,000), \$10,000 from GEN for the Distinguished Trustee Award. \$9,500 for CFMC Employee Matching Gift program.

Loren Steck / Betsy Buchalter Adler, second. Motion passed unanimously.

Ida described the \$69,848 from the Futer Fund for Human and Humane Needs (interfund) grants needing approval.

- o \$17,212 to Child Family Health International

- \$17,212 to Humane Society of the United States

Motion: to approve the Futer Fund for Human and Humane Needs (interfund) grants of \$69,848 Abby Taylor-Silva / Maija West, second. Motion carried unanimously.

NEW FUNDS – Dan Baldwin

Dan Baldwin provided an overview of the new funds, including:

Non-Endowed Donor Advised:

- Hughes-Rivera Family Fund
- Joan Ann Nattress Movement, Exercise, Longevity Fund
- Reed Family Fund

PRESIDENT'S REPORT - Dan Baldwin

Dan described the differences between Charitable Gift Annuities (CGA) and Charitable Remainder Trusts (CRUTS, CRATS) in a PowerPoint presentation. He explained that these are the types of life income investments that require board approval. The board had a thorough discussion about how these instruments work.

Non-Portfolio Assets

Dan reviewed the non-portfolio assets that are embedded in the CFMC financial statements, including: promissory notes receivable, bequests receivable, Charitable Remainder Trusts (CRTs) Charitable Gift Annuities (CGAs), real estate, and oil and gas rights. There was a discussion about the unique stories behind these assets.

3200 17 Mile Drive

Dan and board member Bill Mitchell reported on the analysis of the pricing and marketing for 3200 17 Mile Drive in Pebble Beach. The CFMC's real estate brokers recommended dropping the sale price by \$5 million.

Legislative Update

Dan reported on two legislative bills that are pending in Sacramento. As the chair of the public policy committee for League of California Community Foundations, Dan is actively involved in the outcome of these bills.

- 1. AB1712. Seeks to enact legislation that would relate to donor advised funds for the purpose of improving transparency and accountability.
- 2. AB1338. Has to do with fiduciary training as a requirement for Community Foundation board members.

The board went into Executive Session at 5:50 PM.

CALL TO ORDER - Teri Belli

Teri Belli called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:29 on March 26, 2019 at the Foundation's Salinas office.

APPROVAL OF MINUTES

The minutes were approved to stand as written.

REPORT OF THE CHAIR - Teri Belli

Teri reminded the committee the Women's Fund Luncheon will be held May 16, 2019.

Dan Baldwin outlined the purpose of the Succession Plan and reviewed the changes to the updated version.

The committee discussed the updates and agreed the Succession Plan and staff professional development, to be prepared to act as interim CEO, will be reviewed annually at the March meeting.

On a motion by Jeff Eikenberry, seconded by Ida Lopez Chan, the updated Succession Plan was approved to be presented to the full board for approval.

COMMUNITY IMPACT INVESTING – Dan Baldwin

Dan reported there will be one or two affordable housing representatives attending the April committee meeting.

The committee will be reviewing additional investment opportunities; to meet the goal of having 2% of the long-term portfolio invested by year-end.

INVESTMENT COMMITTEE - Dan Baldwin

Dan reported that in addition to the committee's regular annual goals, the main focus for 2019 is to update the Investment Policy Statement and the portfolio asset allocation.

RESOURCE DEVELOPMENT COMMITTEE - Michael Reid

Michael reviewed the goals of the resource development committee.

Michael reported that at its March 6, 2019 meeting the committee had an in-depth discussion regarding accepting contributions of cannabis related money. At the conclusion, the committee agreed that more research is necessary.

TREASURERS REPORT-Teri Belli

Teri reported the February financial statement will be approved at the April board meeting.

Teri reviewed the goals of the finance committee.

GRANTS AND PROGRAMS COMMITTEE – Ida Lopez Chan

Ida Lopez Chan reviewed the goals of the grants and program committee.

Donor Advised Fund Grants of \$50,000+

The Buffett Fund to the Monterey Bay Aquarium – \$50,000

On a motion by Ida Lopez Chan, seconded by Jeff Eikenberry, the committee approved the \$50,000 grant from the Buffett Fund to the Monterey Bay Aquarium.

GOVERNANCE COMMITTEE - Dan Baldwin

Dan Baldwin explained the process of the governance committee. The committee has not met in 2019, so no formal goals have been developed.

NEW FUND APPROVALS - Dan Baldwin

Agency – Stewardship Fund

- John S. Myszak Scholarship for Future Teachers Fund
- Antle Family Fund
- Ipson-Tully CAL Memorial Scholarship Fund (name change)

Dan Baldwin reported that Maria Salazar Segovia changed the terms of her previously approved CGA; from an immediate distribution to a one-year deferred distribution.

On a motion by Jeff Eikenberry, seconded by Ida Lopez Chan, the committee approved the deferred CGA, in the amount of \$75,000, from Maria Salazar Segovia.

PRESIDENT/CEO REPORT - Dan Baldwin

Dan Baldwin presented Inactive Funds Policy and explained we have very few inactive funds, but the policy is required to be in compliance with National Standards, and that the policy is also important to be in place due to all the current scrutiny regarding donor advised funds.

The committee fully discussed the policy and decided the time line should be reduced by one-year, resulting in a six-year timeframe before a fund is declared fully inactive.

On a motion by Ida Lopez Chan, seconded by Jeff Eikenberry, the Inactive Funds Policy, with the one-year modification, was approved to be presented to the full board for approval.

Dan reviewed the status of the 3200 17 Mile Drive property and the offer that was received. Dan explained the committee had met with the realtors and decided on a counter offer. The counter offer was not accepted and there was no further action.

Dan informed the committee the hearing regarding an adjustment to the \$41 million assessment is scheduled for April 26, 2019. The CFMC has secured its own appraisal and hopes to settle on a new assessed value prior to the April 26 hearing.

Dan reviewed the two legislative bills currently being discussed, one regarding board members becoming fiduciaries and the other regarding donor advised funds.

Dan informed the committee he is the chair of the League of California Community Foundations' public policy committee and that he is spending a lot of time working with other league members on the two bills.

Dan Baldwin welcomed everyone and passed the meeting to Tim Allen of Coldwell Banker and Michael Canning of Sotheby's International Realty.

Mike and Tim did a review of showings for 3200-4 17 Mile Drive, a market analysis of past sales, pending listings and current listings. They talked about current market condition for high-end properties. They believe the market for 2019 will be flat for high-end properties. Bill Mitchell agreed with that assessment and commented that the high-end market began to slow toward the end of 2018.

Mike and Tim then presented an artist rendering of a possibility of what the property could look like after a remodel. They will use the artist rendering in future showings. They then discussed the plans of doing a lot line adjustment, the time line for approval of the lot line adjustment and the pricing strategy going forward.

It was agreed by Bill, Teri Belli and Birt Johnson, Jr. to reduce the selling price of 3200 17 Mile Drive to \$19,950,000. They also agreed to keep the current price of the vacant lot (3204 17 Mile Drive) and move forward with the lot line adjustment.

The Impact Investment Committee of the Community Foundation for Monterey County was called to order by Nolan Kennedy at 3:30 PM on April 9, 2019.

Nolan welcomed the guests then turned the meeting over to Dan Baldwin.

Dan Baldwin reviewed the history of the Community Impact Investing program and asked what impact a \$1,000,000 investment would have on affordable housing projects in Monterey County.

Alfred Diaz-Infante and Betsy Wilson described their agencies, the projects they are working on and their various funding sources.

The committee had a lengthy discussion regarding current and future housing projects, and the challenges of land, water and funding restrictions/requirements.

Alfred, Norm and Betsy were thanked for their participation in the meeting and were excused.

Loren Steck suggested an alternative use could be to provide bridge loans for the 12 behavioral health agencies that are funded through reimbursements from the County of Monterey. Due to a new computer system, the reimbursements are delayed which is causing cash-flow problems.

Nolan Kennedy commented that unless the agencies have a sufficient cash reserve, a short-term loan will not solve their ongoing cash-flow problems.

The committee discussed various options and agreed to have a sub-committee decide on a loan structure to be presented to the executive committee at its May meeting.

Dan Baldwin will share materials he has received from other community foundations that have an impact investment program.

Community Foundation for Monterey County President/CEO Succession Plan 2019

Introduction

Succession planning is more than just replacing the president/CEO (CEO). It reflects organizational culture and long-term goals. While the departure of the CEO can be a disrupting event for the board of directors, staff, and constituents of an organization, the smooth handling of a CEO transition can communicate many positives to the staff, fund holders, grantees and general public.

Questions of who's in charge, what is the board's role, how is it communicated internally and externally, and how the organization proceeds with operations while finding a successor are much better handled when a plan is in place. Having an agreed upon plan not only allows the board of directors to find a successor CEO in an expeditious manner, but it is an opportunity to demonstrate stability and seek a replacement consistent with the organization's vision.

Decisions related to a CEO departure must consider circumstances present at the time, and which may not be anticipated in this document. As such, the succession plan describes both a sudden or planned departure of the CEO and considers CFMC organizational dynamics at the time of its writing. As the organization changes (particularly personnel and staff structure), the succession plan should be reviewed and changed accordingly.

Who is in charge?

The chair of the board of directors is the primary authority for the CFMC. However, it is inappropriate for the chair or other board member to assume day-to-day operational oversight, unless under the most extreme circumstances. Should there be a sudden departure of the CEO (death, disability, firing, resignation with short or no notice) the board of directors should first look to staff for an interim president.

Currently, the CFMC has three vice-presidents (philanthropic services; grants and programs; finance and human resources). On days when the CEO is absent the three vice presidents work together as a single officer in charge. Should the need arise for the appointment of an interim CEO, the vice president for philanthropic services should be named. The holder of this position has the most involvement with the widest segment of the CFMC's operations, and also has frequent interactions with the largest number of board members. From an external viewpoint, the VP for philanthropic services is acquainted with our fund holders and nonprofits, which should have a calming effect on how the CFMC will be run during the transition. However, an internal executive team made up of the three vice presidents should meet weekly and allow the board chair to sit in as appropriate.

Should the executive committee feel it better to seek an interim CEO from outside the staff, it is not uncommon for this role to be filled by recently retired business or nonprofit executives. It would not be appropriate to bring in a former employee of the CFMC, as they may want to operate within a culture that no longer exists at the CFMC. If it is decided that a sitting board member will fill the role, that individual, upon accepting the position, should resign from the board of directors.

In the case of a planned departure, it is hoped that a successor can be found prior to the CEO leaving. However, if that cannot be accomplished, the CEO will hold transition meetings with the executive committee and the interim CEO. It is important that the CEO's job description is kept current and available to the chair of the board and the interim CEO.

Organizing the search

The executive committee shall act as the initial search committee for replacing the CEO. The board may want to form a separate committee that includes past chairs/board members or members of the community. This committee can report to the executive committee, which, in turn, will report to the board of directors. Whether the departure is sudden or planned, the search should be put into motion immediately, the executive committee should hold a meeting within 48 hours of the departure; however, the process should be thorough and completed only when the board of directors feels the proper candidate has been found.

Internal candidates are welcomed and should be afforded the minimum courtesy of an interview. No staff should serve on the search committee.

The geographic breadth of the search is at the discretion of the search committee; however, the CFMC has a national profile and should be considered an attractive position. The search committee may want to engage a search firm. There are several that specialize in nonprofits. This information can be obtained through a variety of sources, including the Council on Foundations.

The CFMC director of communications should be consulted and/or utilized to write all job announcements and provide insight as to their dissemination. Web postings should include links to the CEO job description, the strategic plan under which the organization is currently operating, and a description of the organization (assets; grant programs and grant totals; leadership initiatives; size of the staff; and, a brief description of the community and the CFMC's role). The announcement should be featured prominently on the CFMC web site.

It is appropriate for the board of directors to encourage applications, so long as no indication of preference is given or implied.

Defining qualifications for the CEO is the responsibility of the search committee. However, the search committee should seek advice from the board of directors, staff, fund holders, and, if appropriate, leaders from other community foundations and local community leaders. In the case of a planned departure, the sitting CEO can be consulted

on qualifications, but should not be an active member of the search committee.

The search committee will outline its process to the board of directors. When the search committee has narrowed its search to two to three finalists, a special meeting of the board of directors should be called, at which time the search committee will report on the interviews and discuss the finalists. Compensation ranges should be known to the candidates, and the development of a compensation package is the responsibility of the CEO compensation committee, in consultation with the board of directors. The chair of the board should negotiate final terms with chosen candidate.

Communications

The director of communications should coordinate all media announcements and board of directors talking points related to the sudden or planned departure of the CEO and the hiring of a successor. The chair should be the primary CFMC spokesperson.

A press release describing the tenure of the CEO should be drafted, periodically updated, and kept on file. Language related to a sudden departure can be written at the time of the event.

Continuing preparedness role of president/CEO

The CEO has an important, continuing role in ensuring the CFMC experiences a smooth transition for a sudden or planned departure. The CEO must always be developing staff that can assume greater responsibility in the absence of the CEO. The CEO will keep the chair and vice-chair of the board informed on the professional development and leadership status of the CFMC's vice presidents, and their role in the ongoing operations.

The CEO/CFMC must maintain a commitment to professional development for the staff. Leadership training, conferences, committee work, etc., while at times seem like distractions from everyday work, are important in building skills and networks so staff are prepared to lead under changing circumstances.

The CEO will keep the office administrator informed of his/her filing system, so this can be communicated to a successor.

As the organization changes (particularly personnel and staff structure), the succession plan should be reviewed and changed accordingly.

Who is in charge?

The chair of the board of directors is the primary authority for the CFMC. However, it is inappropriate for the chair or other board member to assume day-to-day operational oversight, unless under the most extreme circumstances. Should there be a sudden departure of the CEO (death, disability, firing, resignation with short or no notice) the board of directors should look first to the staff for an interim president. Currently, the CFMC has one vice-president (vice-president for grants and programs). This individual serves as officer in charge in the absence of the CEO. It is possible other vice-president positions will be created in the future. Should the executive committee feel it better to seek an interim CEO from outside the staff, it is not uncommon for this role to be filled by recently retired business or nonprofit executives. If it is decided that a sitting board member will fill the role, that individual, upon accepting the position, should resign from the board of directors.

In the case of a planned departure, it is hoped that a successor can be found prior to the CEO leaving. However, if that cannot be accomplished, the CEO will hold transition meetings with the executive committee and the interim CEO. It is important that the

CEO's job description is kept current and available to the chair of the board and the interim CEO.

Organizing the search

A press release describing the tenure of the CEO should be drafted, periodically updated, and kept on file. Language related to a sudden departure can be written at the time of the event.

Continuing preparedness role of president/CEO

The CEO has an important, continuing role in ensuring the CFMC experiences a smooth transition for a sudden or planned departure. The CEO must always be developing staff that can assume greater responsibility in the absence of the CEO. The CEO will keep board leadership informed of the strengths of key staff, and their role in the ongoing operations.

The CEO/CFMC must maintain a commitment to professional development of the staff. Leadership training, COF conferences, committee work, etc., while at times seem like distractions from everyday work, are important to building skills and networks so that staff are prepared to lead under changing circumstances. An ongoing organizational commitment to staff development must be maintained.




ASSET ALLOCATION \$183,358,572 at 3/31/2019 Pooled Endowment Portfolio Asset Allocation



Assets

Total Assets through 2/28/2019 are \$256,938,243 a 2.4% decrease since February 2018 and a 3.33% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$1,840, and unrealized gains were \$12,260,056, for a total gain of \$12,258,216.

Operating Fund

Total revenue was \$66,721 more than the budget, and total expenses were \$98,860 less than the budget, unrealized gains were \$22,952 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$368,934 compared to a budgeted deficit of \$490,746.

Note: The Expendable Operating Cash-on-Hand is at 3.9 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 2/28/2019 was \$180,080,408. The one-year Total Return for the Long-Term Endowment Portfolio was .08% compared to the Policy Index of 1.4%.

The market value of the Medium-Term Fund portfolio at 2/28/2019 was \$5,034,454. The one-year Total Return for the Long-Term Endowment Portfolio was 1.4% compared to the Policy Index of 2.2%.

The market value of the ESG Fund portfolio at 2/28/2019 was \$3,443,134. The one-year Total Return for the Long-Term Endowment Portfolio was 1.1% compared to the Policy Index of 1.8%.

The market value of the DRIM Fund portfolio at 2/28/2019 was \$2,812,024. The Total Return for the DRIM Portfolio, since inception, was 1.2% compared to the Policy Index of -9.2%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking

Assets

Total Assets through 3/31/2019 are \$257,967,312 a 1.52% decrease since March 2018 and a 3.75% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018. In March, Maria Segovia Salazar established a CGA valued at \$75,000, with a calculated remainder value of \$29,886, the remainder will establish the Refugio Alberto Manuel Fund, for the benefit of Gateway Center of Monterey County.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$2,497, and unrealized gains were \$13,481,869, for a total gain of \$13,479,372.

Operating Fund

Total revenue was \$17,244 more than the budget, and total expenses were \$45,492 less than the budget, unrealized gains were \$29,706 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating surplus is \$23,553 compared to a budgeted deficit of \$68,771.

Note: The Expendable Operating Cash-on-Hand is at 5.7 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 3/31/2019 was \$184,741,731. The one-year Total Return for the Long-Term Endowment Portfolio was 2.5% compared to the Policy Index of 3.2%.

The market value of the Medium-Term Fund portfolio at 3/31/2019 was \$5,301,632. The one-year Total Return for the Long-Term Endowment Portfolio was 3.3% compared to the Policy Index of 4.0%.

The market value of the ESG Fund portfolio at 3/31/2019 was \$3,506,387. The one-year Total Return for the Long-Term Endowment Portfolio was 2.9% compared to the Policy Index of 4.2%.

The market value of the DRIM Fund portfolio at 3/31/2019 was \$2,743,866. The Total Return for the DRIM Portfolio, since inception, was 3.8% compared to the Policy Index of -6.08%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College

Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$383,017 and total expenses were \$5,407,645, which includes grants totaling \$5,295,709 from the 2018 Monterey County Gives campaign.

Active Funds Policy

(Draft, March 2019)

To carry out its mandate of granting charitable dollars, the Community Foundation for Monterey County (Foundation) periodically reviews the grantmaking activity of all donor-advised funds. The Foundation contacts donor advisors at least annually and encourages them to retain an active role in their donor-advised fund. Donor advisors who would like to delay recommendations for grantmaking in order to recommend a significant grant at a later date, or other circumstances, should communicate such to the Foundation, preferably via letter or email. These communications will be archived, and philanthropic services staff will periodically confirm with donor advisors that this remains their course of action.

If a donor-advised fund has made no grants for two consecutive full calendar years, the Foundation will contact the donor advisor(s) to encourage grantmaking and discuss intentions for the fund. The Active Funds Policy will be shared with the donor advisor(s). They will be notified that if a grant is not made in the next year, the active funds policy will be implemented.

If the donor advisor(s) is unresponsive and/or the fund does not make any grants for another year (three consecutive full calendar years with no grants) the advisor(s) will be given written notice via registered letter encouraging grantmaking and reminding them of the Foundation's Active Funds Policy.

In the event the fund has made no grants, the advisor cannot be located or is unresponsive for a third year, the fund – whether endowed or non-endowed – will have that year's board-approved payout rate for endowed funds applied to the previous year-end fund balance, and the proceeds of such application will be utilized in the Foundation's primary discretionary grantmaking program as an unrestricted addition (currently the Community Impact grant program). If this continues for three additional years, and there is no communication from the donor advisor(s), the fund will be declared fully inactive. If the donor advisor(s) has provided the Foundation instructions on the use of the fund at their death or resignation, whether in the fund agreement or separately in writing, the fund will be administered in accordance with these instructions. Should there be no instructions, the fund will become a named component fund of the Foundation's unrestricted endowment.
