# **Background and Mission:**

## Background:

The Stevenson Student Philanthropy Project, founded in 2019, is an annual effort that allows a group of Stevenson 9-12 graders to act as a foundation, serving as grantmakers and learning strategic philanthropy. The goal of the project is to accept grant proposals from Monterey County nonprofits, review the expressed needs, and grant money to the chosen organizations (\$25,000 is available for the 2019-2020 year). This project was made possible through the generosity of the Hillstrom Family and seeks to foster relationships between Stevenson students and Monterey County nonprofits while educating students on philanthropy.

#### Mission:

The 2020 Philanthropy Project\* aims to promote friendly, supportive, and informative interactions between Stevenson students and the Monterey County nonprofit community and seeks to strengthen and empower the youth and families of Monterey County by funding programs that:

- focus on improving their mental and physical health,
- create stability and comfort in their lives,
- and provide them with second chances or opportunities to succeed.

\*Each year, the students will have the opportunity to adjust the mission and funding priorities.

# **Requirements and Timeline**

<u>Eligibility</u>: Organizations must be a 501(c)3 organization located in Monterey County. Applicants must display a high level of responsibility and sound governance.

<u>What we will fund</u>: We have \$25,000 in total funding which will be granted to between 1-5 organizations. Preference will be given to capital and start-up funding requests. Grant sizes may range from \$2,000-\$25,000 depending on how many organizations are selected.
