CALL TO ORDER

Board chair Teri Belli called the meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:33 PM, Tuesday, February 23, 2021.

Consent Agenda – Teri Belli

Teri Belli requested the board read the consent agenda before meetings to cut down on the extra time used for committee reports. She asked for any comments from the consent agenda.

Francine Rodd clarified she was not the person quoted speaking about “early childhood needing to be funded” in the board retreat minutes.

Motion: to approve the Consent Agenda as presented.

Loren Steck / Birt Johnson second. Motion carried unanimously.

REPORT OF THE CHAIR – Teri Belli

Teri reported board meetings in 2021 are going to be slightly different with more time for special topics, presentations, and discussions.

The Legacy Luncheon will be a Zoom meeting on March 16 from 1:00-2:00 p.m. celebrating the generosity and impact of CFMC Legacy Society members. All board members are encouraged to attend.

The board retreat had 100% attendance and Teri thanked the board for their participation and engagement.

TREASURER/FINANCE COMMITTEE – Jan Vanderbilt

Jan reviewed the financial statements for November and focused on the December year end statement. She highlighted MC Gives and clarified the variance in line-item contributions for 2020 vs grants out for 2019. There was a request for a chart to compare the year over year campaign for MC Gives.

Jan noted the increase in total assets for 2020 year-end vs 2019.

Jan reported on the operating fund vs actual statement and described the bequests and variances that happen each year. CFMC was under budget expense due to changes in events and staffing. At December 31, 2020 there are 8.8 months of cash reserves.

Dan described the sources, types, and uses of funds as a future topic for the board to dive deeper into funds and grant making.

Motion: to approve the November 30, 2020 and December 31, 2020 financial statements. Jan Vanderbilt / Loren Steck second. Motion carried unanimously.

INVESTMENT COMMITTEE – Giff Lehman

Giff reported on the portfolio summaries of the Long term, Mid-term and ESG funds.

The investment committee reviewed the index reports and asset allocations and found the portfolios in good shape and found no changes were needed.

The DRIM (Donor Requested Investment Management) policy will be reviewed for compliance with the investment policy statement. Dan described that it is common for community foundations to hold these types of agreements.

COMMUNITY IMPACT COMMITTEE– Betsy Buchalter Adler

Betsy reported on the 511 grants from December 1, 2020-January 31, 2021 totaling \$4,263,123 that went into the community. She described the ratification of grants process for the new board members.

Motion: to approve 511 grants from December 1, 2020-January 31, 2021 totaling \$4,263,123.00 Betsy Buchalter Adler / Maija West second. Motion carried unanimously.

Betsy reviewed the proposed fund allocations for 2021. The beginning balance of the Unrestricted and Field of Interest (FOI) funds available for grantmaking is: \$2,063,305. The annual disbursements totaling \$200,500 are allocated from the Unrestricted funds, leaving \$1,862,805 available for the Community Impact (CI) grantmaking program.

Annual Disbursements:

- \$150,000 for the Opportunity Fund:
- \$5,000 to support Leadership for Community Transformation
- \$15,500 for various grants (MC Gives! awards and match: \$14,500; Philanthropy Day awards: \$1,000).
- \$10,000 for CFMC Employee Matching Gift program (\$500 allocated for each of 20 employees).
- \$10,000 CFMC's annual Distinguished Trustee award grant.
- \$10,000 for 2020 Neighborhood Grants that were deferred to 2021. Note: Every year, we allocate \$50,000 to the Neighborhood Grants Program (NGP) for small grants to grassroots, mostly voluntary associations of neighborhood residents coming together around community improvement efforts. For 2021, NGP is "on pause" due to the pandemic.

Laurel Lee-Alexander described the allocation for NGP will reduced to \$10,000 and be paused for 2021 due to the pandemic.

Motion: to approve the 2021 fund allocations as presented. Betsy Buchalter Adler / Elsa Jimenez Mendoza second. Motion carried unanimously.

PHILANTHROPIC SERVICES COMMITTEE - no report

NEW FUNDS - Dan Baldwin

Dan described the two new funds created by Nancy Bletzer's bequest.

CEO REPORT

Every year at the February meeting there are resolutions that need to be approved by the board. The real estate resolution and investment transaction resolution.

Motion: to approve the 2021 resolution as follows: "Resolved that Daniel R. Baldwin, President/CEO is hereby authorized and empowered to convert, endorse, sell, assign, set over and deliver any and all shares of stock, bonds, notes or other securities standing in the name of or owned by this organization and to make, execute and deliver any and all written instruments of assignment and transfer necessary or proper to effectuate the authority hereby conferred."
Joe Pezzini / Kirk Gafill second. Motion carried unanimously.

Motion: to approve the 2021 Real Estate resolution as follows: " RESOLVED that Daniel R. Baldwin, President/CEO is hereby authorized and directed to transact, negotiate and enter into any and all real estate transactions by or in the name of this corporation and in connection therewith to execute and deliver, in the name of the corporation Deeds, Mortgages/Deeds of Trust, Notes, Agreements for Sale, Escrow Instructions and any and all instruments necessary to properly consummate such transactions in accordance with the purpose of this resolution."
Loren Steck / Birt Johnson second. Motion carried unanimously.

Dan reviewed the non-traditional assets that CFMC holds. He noted the growth of CFMC through estate plans, and others are more complex with different scenarios that convert to charitable gifts over time. Charitable Remainder Trusts (CRT) and Charitable Gift Annuity's (CGA) have different arrangements that need approval by the board. Dan described the differences between a CGA and CRT.

CFMC has a real estate LLC to separate real estate holdings to reduce liability to the foundation.

BOARD PRESENTATIONS:

Board Retreat follow-up

Teri led a discussion about the board workplan for 2021.

The ideas generated at the retreat focused on DEI and whether to develop a board DEI Committee, whether to have a DEI board workshop, how to apply an equity lens for investments and policies.

Comments: Should the board and staff DEI committee work together or separately? There could be synergy to have staff and board work together, but it was not decided how to structure the committee.

After a thorough discussion, there was agreement that a DEI board committee should be considered. The board wants to integrate DEI into meaningful results. The committee would be tasked with creating a plan and have regular check ins at the board meetings with next steps.

Covid-19 Initiative discussion

Dan Baldwin, Erika Matadamas and Michael Castro gave a PowerPoint presentation on the work of the Covid-19 Collaborative. Dan summarized how in 2020 CFMC convened a diverse group of leaders from the County, agriculture, community-based organizations, hospitality, healthcare, education, labor and philanthropy to address COVID 19 and its impacts on our community. One goal is to advance a coordinated action plan driven by science and best practices in public health and equity that will drive down Covid-19 infections in the most vulnerable communities.

The board went into executive session at 5:15 PM.

CALL TO ORDER – Teri Belli

Teri Belli called the Zoom meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:33 on March 23, 2021.

APPROVAL OF MINUTES

Motion: to approve November 24, 2020 minutes as written.

Birt Johnson, Jr / Betsy Buchalter Adler second. Motion carried unanimously.

REPORT OF THE CHAIR – Teri Belli

DEI Update

Teri reviewed the board's interest in prioritizing the diversity, equity and inclusion (DEI) values into the board's work. Teri, Dan and Laurel presented the idea of creating a board work group based on the model of the CFMC's staff DEI work group rather than starting a formal committee. The thought is to create a melded staff and board work group that represents CFMC's overall values.

Laurel presented a brief overview of what has been accomplished by the staff. She highlighted the history of CFMC's DEI values over at least 20 years in grantmaking, initiatives, training, CNE workshops, LEAD and a broad range of partnerships. The staff's work group has created a set of priorities, values, resources, best practices as a framework for the board members to join.

The committee agreed that the board and staff work group concept is the most efficient and meaningful approach to DEI. The executive committee will make a recommendation at the April board meeting to move forward with the combined work group.

TREASURERS REPORT- Teri Belli for Jan Vanderbilt

Teri reported the January and February financial statements have not been reviewed by the finance committee and will approved at the April board meeting.

Diane Nonella reported the 2021 outlook for the finance committee is to review the cash reserve and cash management policy.

The audit field work was completed, and they are on track to present the audit at the April meeting for acceptance.

INVESTMENT COMMITTEE – Giff Lehman

Giff reported the investment committee outlook for 2021 is oriented toward making the committee time more efficient and effective. They will work with Verus to memorialize decisions and have an archive for why decisions were made in the past. The second goal is to have voluntary educational investment seminars on topics relevant to the committee's agendas.

COMMUNITY IMPACT INVESTING – Nolan Kennedy

Nolan reported the committee will work in 2021 on refining their procedures. They have hired a consultant to assist with what to invest in, and how to report to the board. The consultant will provide quantifiable data about the impact and risk of the investment. The committee learned in the last 2 years that the "loan" market is not in high demand, so they are researching other investments that would come with impact. They will bring a report to the April board meeting.

PHILANTHROPIC SERVICES COMMITTEE – Christine Dawson for Betsey Pearson

The 2021 PS goals will include capacity building and streamlining of systems. An eight-week process transformation training is underway with a consultant which will continue throughout the year. New technology is being tested to assist with the need to track relationships going forward. The new position of Andrea Scott as Director of Gift Planning is assisting in the technology implementation and process redesign.

The events for 2021 are all being researched for how they will be best designed to include the health protocols needed for gatherings.

The PS committee has a goal to include DEI in their communications and education events. Rather than form a separate sub-committee they will be involved in the board and staff DEI workgroup.

Awareness for the impact of the Fund for Monterey County is a priority for 2021. The PS team will be informing donors, legacy society members and professional advisors to the broad uses of the Fund for Monterey County.

COMMUNITY IMPACT COMMITTEE – Betsy Buchalter Adler

Betsy reviewed the CI outlook for 2021 which includes expanding the ability of the staff to assist with other CI programs and initiatives. For example, the Covid-19 Collaborative is a cross sector initiative that will focus on equity and diversity to best assist the community to cope with the pandemic.

The CNE has had greater attendance in their workshops during the pandemic with Zoom presentations. The CNE is assessing how to structure their programs to take advantage of the more inclusive virtual technology.

GOVERNANCE COMMITTEE – Birt Johnson, Jr.

Birt reported the governance committee has two primary goals. One is nominations and the other is to review the By-Laws as part best practice. There are two members terming off this year. There is a matrix created to help the committee determine the areas that need to be filled. The committee will assure that candidates represent a broad cross section of the views and interests of the residents of Monterey County, and fill areas of special expertise needed on the board.

NEW FUND APPROVALS – Dan Baldwin

Dan described how the new funds represent a wide variety of perspectives. He emphasized the

strong relationships with professional advisors that often present CFMC with complex estates.

PRESIDENT/CEO REPORT - Dan Baldwin
Not on the agenda-Donor Advised Fund Legislation

A two-year bill has been reintroduced to the legislators. There is a survey from the Attorney General's office that CFMC will participate in and Dan will continue to work with LCCF to educate legislators.

Distinguished Trustee

May is the meeting when the Executive Committee chooses the recipient of the Distinguished Trustee Award. The 2020 award was cancelled due to Covid-19. The 2021 Distinguished Trustee will be honored at the Celebration of Philanthropy in whatever format the event may take.

Real Estate update

There is a commercial property in 1075 South Main in Salinas appraised at 2.45 million. There has been an offer with contingencies. The CFMC counsel and realtor are working on closing the sale. There will be an update at the April board meeting on the sale of the property.

Covid 19-update

Dan noted there is an irony to the tragedies of the Covid pandemic in that CFMC has responded to the challenges with great success. There are donors that have created new relationships and grantmaking is bigger than ever. The county wide Covid 19 Collaborative is led by Dan and a core CFMC staff team. The Packard Foundation has contributed two project manager positions and support to nine community-based programs. With the emphasis on vaccines, Dan recommended a landscape study of all the vaccination sites, capacity, and participation data be gathered in one place. The priority for testing is still very critical and the collaborative is educating the community to stay diligent.

The return to the offices is a topic of discussion and planning. The county recommendation is still to work remotely. There is no timetable to return at this point, but staff members are working on an internal survey and next steps.

The meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Jan Vanderbilt, CPA at 2:03PM on February 23, 2021. The meeting was conducted via Zoom.

Minutes

On a motion by Birt Johnson, Jr, seconded by Joe Pezzini, the November and December 2020 Finance meeting minutes were approved.

Jan welcomed Abby Taylor-Silva to the Finance Committee.

Financial Statement Review

Jan led a discussion on the December 2020 year end Statement of Financial Position and Statement of Activities:

- Noted 2020 MC Gives grants have yet to be disbursed and will explain to the greater board that the grants reflect 2019 numbers.
- Total assets have increased by \$56 million and net assets increased by \$9 million from 2019.
- Grants increased by \$6.4 million
- Total gain on investments \$20 million
- \$5.5 million realized loss was due to the repositioning of the alternative investments section of the portfolio (commodities fund)

Operating Budget

- Diane explained Misc. expense variance due to proceeds from Women's Fund Virtual Event being transferred to GHGH Scholarship fund. Normally income would be offset by expenses from the event.
- Dan noted majority of surplus is found in the two lines of Salary/Wages (staff changes) and Bequests Received of which neither could be predicted for 2020.

Operating Cash on Hand and Reserve

- Committee agreed 8.8 months reserve is prudent given the current climate.

On a motion by Joe Pezzini, seconded by Teri Belli, the committee approved the November and December 2020 Financial Statements.

Discussion Items

Growth at a Glance

Dan Baldwin reviewed the Growth-A-Glance charts with 2020 year end information for Total Assets, Total Grants, Total Contributions, Operating Contributions, Operating Expenses, and Staff.

Staffing Update

New positions to fill in 2021 that are not in the budget.

Finance Department succession plan

Kim Drabner brought on as Director of Finance and Sarah Elias moved to Accounting Associate position. Finance will be adding a fourth position that fall in between these two levels. Internal discussions are ongoing for filling the VP of Finance position and how it will proceed. Priority will be given to updating finance procedures.

Systems Analysis

Gift process will be first examined. Full staff will begin meeting in early April with Lee Kuntz from Innovation Process Design to start the initial process.

Audit Committee Minutes March 31, 2021

The meeting of the Audit Committee of the Community Foundation for Monterey County was called to order by Loren Steck at 9:01 a.m.. The meeting was held via Zoom.

Once called to order, the meeting was turned over to Kim Said, CPA. Kim gave a brief overview of Hutchinson & Bloodgood, LLP (audit firm). She then turned the meeting over to attendees for committee introductions before moving to the presentation of the audit plan.

Hutchinson & Bloodgood, LLP Presentation

Kim reviewed the 2020 audit plan to include:

- Focus of areas of testing
 - Investments – test for proper valuation, allocation of income, recording period: No areas of concern were noted during testing.
 - Assets held in CRT and CGA investment instruments – test for proper valuation, existence, and confirmed calculations with Kaspick: No areas of concern were noted during testing.
 - It was noted that the calculations were converted from completion in-house to being prepared by Kaspick a few years ago.
 - Substantive testing was done in the year of conversion to confirm Kaspick calculations.
 - Contributions received – test for proper recognition and review for restrictions.
 - Expenses – performed payroll and grant disbursement testing.
 - It was noted that there is a variance on the accrued vacation reported by management. Management passed on making an adjustment for 2020.
 - Amount of adjustment is below level of materiality and will not be reported in audit (management file item only).
 - Management to evaluate accrual for 2021 for potential adjustment.
- Non-audit services to be performed include assistance with preparation of the financial statements and tax returns.

Other Items

Kim noted that, due to the retirement of Diane Nonella, which is a significant event, the 2021 audit will include interim procedures and asked for questions. Questions were raised about the timing. Kim clarified that the interim procedures will be performed shortly after Diane's departure and noted that it is considered a best practice given the circumstances. The interim procedures are considered part of the regularly scheduled audit (not an additional scope of work).

Management and staff were excused and the committee and Kim Said went into closed session at 9:22 a.m. The meeting was adjourned from closed session.

Hutchinson & Bloodgood, LLP Presentation

- Required Communication
- Graphical presentation of financial results.

Discussion Items

Kim complimented Diane Nonella on her responsiveness and cooperation allowing for a timely completion of the audit. She then asked if there were any questions.

Dan asked when the De Guigne property was recorded. Kim noted that the revenue for the property was recorded in 2017. The recent sale of the property was a reclassification from land held for sale to investments in 2020.

Dan opened a discussion on the use of “income” in Note 2. Availability and Liquidity. Kim will bring forth samples of modified language to reference the spending policy application as provided under Uniform Prudent Management of Institutional Funds Act (UPMIFA) to align with current practice for amendment to the current note.

The committee complimented Kim on the use of graphics. Terri asked for clarification on whether the graphical presentation was the full presentation intended for the Board. Kim confirmed that was her intent with no plan to review the financial statements in detail. However, time will be allowed for any questions on the financial statement detail brought forward by the Board.

Having no further business, staff was excused, and the committee went into closed session at 11:25 a.m.. The meeting was adjourned from closed session.

Community Impact Investment Committee Minutes March 30, 2021

Present: Nolan Kennedy, Chair, Richard Aiello, Teri Belli, Kirk, Gafill, Giff Lehman, Fred Meurer, Loren Steck and William Tebbe

Staff: Dan Baldwin, Kim Drabner and Diane Nonella

Guests: Marc Rand, Community Capital Advisors

The Community Impact Investment Committee of the Community Foundation for Monterey County was called to order by Nolan Kennedy at 4:00 PM on March 30, 2021. The meeting was conducted via Zoom.

Discussion Items

Marc Rand, Community Capital Advisors, was introduced by Dan Baldwin. Marc presented the CFMC Impact Investing Portfolio Report for the quarter ending December 31, 2020. The presentation concluded at 4:15 PM and Marc opened the floor to questions.

Clarification was sought on the grant funds reported. Dan noted that all grant funding reported came from the Community Foundation. A question was raised on whether the reported impact was fully related to the Community Impact loans. Marc and Dan spoke to the influence the grants received have on overall agency operations and capacity noting that it is difficult to separate agency impact to the loans only. The grants will have influence on the impact.

It was noted that Accion Opportunity Fund has not yet loaned out their full borrowing. Marc stated that, given the conditions of the past year, he is not concerned about the partial deployment of funds. Accion is actively working with borrowers to fully deploy the funds. Marc expressed more concern about the lack of withdrawals by California Coastal Rural Development Corporation (Cal Coastal) against their approved loan.

The discussion then moved to the issue of Cal Coastal and Mission Economic Development Agency (MEDA) investments.

- Cal Coastal:
 - Marc noted that Cal Coastal is actively seeking “free” money diminishing their interest in drawing on the approved loan.
 - Dan noted that the Irvine grant made to Cal Coastal by CFMC was part of the “free” money received by Cal Coastal. However, the loan prompted the Irvine grant, which had significant benefit to the community, so the overall result was a positive impact.
 - Input was sought on whether to seek to extend or cancel the Cal Coastal loan.

MOTION: Giff Lehman made a motion to cancel the Cal Coastal loan funding. Dan Baldwin clarified the intent to cancel at the end of the draw period (May 15, 2021) and not an early termination. Giff confirmed the intent to cancel at the end of the draw period. The motion received a second from Bill Tebbe. The motion passed unanimously.

- MEDA:
 - Marc noted that MEDA is currently experiencing capacity issues limiting their ability to deploy funds.
 - Dan discussed their continued interest in deploying the funds once capacity issues are resolved and suggested extending the draw period based on MEDA interest.
 - It was suggested that a no cost one-year extension, based on MEDA interest in continuation, be considered.

MOTION: Loren Steck made a motion for a no cost extension to the current draw period for MEDA of one (1) year. The motion received a second by Bill Tebbe. The motion passed unanimously.

The topic moved to the Community Impact Investing loan program. Nolan noted it was to be a discussion only and that no action would be taken.

The conversation included discussion on:

- Lack of internal expertise in loan provision / servicing and underwriting.
- Challenges related to underwriting in difficult economic times for non-profits and the possibility of delaying until the economy stabilizes.
- Preference for CFDI loans given internal staffing limitations.
- Possibility of doing a “landscape scan” for non-profit needs.

The committee further discussed the need for, and structure of, an investment policy that addresses risk assessment, credit guidelines, and loan procedures. The committee decided that additional discussion is warranted. Dan, with input from Marc Rand, will draft additional policy and procedure documents for input from the committee.

Having no further business, the meeting was adjourned 5:00 PM.

Assets

Total Assets through 2/28/2021 are \$344,066,738 a 19.76% increase since February 2020 and a 1.23% decrease since December 2020.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$1,721, and unrealized gains were \$6,145,487, for a total gain of \$6,147,208.

Operating Fund

Total revenue was \$13,646 more than the budget, and total expenses were \$6,673 less than the budget. Unrealized losses were \$2,041 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$471,484 compared to a budgeted deficit of \$489,701.

Note: The Expendable Operating Cash-on-Hand is at 6.9 months, excluding the operating reserve of \$500,000, the building reserve of \$150,000, and including the PPP Loan of \$411,402, which is expected to be forgiven.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 2/28/2021 was \$285,330,397. The one-year Total Return for the Long-Term Endowment Portfolio was 20.8% compared to the Policy Index of 18.9%.

The market value of the Medium-Term Fund portfolio at 2/28/2021 was \$8,943,637. The one-year Total Return for the Medium-Term Endowment Portfolio was 14.2% compared to the Policy Index of 11.8%.

The market value of the ESG Fund portfolio at 2/28/2021 was \$4,507,262. The one-year Total Return for the ESG Portfolio was 16.7% compared to the Policy Index of 18.4%.

The market value of the DRIM Fund portfolio at 2/28/2021 was \$2,523,741. The one-year Total Return for the DRIM Portfolio was 27.5% compared to the Policy Index of 41.1%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$75,552 and total expenses were \$7,803,731, which includes \$7,702,746 in grants from the 2020 Monterey County Gives campaign.

Assets

Total Assets through 3/31/2021 are \$350,913,535 a 35.1% increase since March 2020 and a .73% increase since December 2020.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. In April, Marc Rosen added \$120,000 to his CRT, with a calculated remainder value of \$15,618.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$1,419, and unrealized gains were \$9,373,915, for a total gain of \$9,375,335.

Operating Fund

Total revenue was \$511,263 more than the budget, and total expenses were \$50,116 less than the budget. Unrealized losses were \$4,212 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating surplus is \$587,329 compared to a budgeted surplus of \$30,252.

Note: The Expendable Operating Cash-on-Hand is at 10.6 months, excluding the operating reserve of \$500,000, the building reserve of \$150,000, and includes the PPP Loan, which was fully forgiven March 31, 2021.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 3/31/2021 was \$291,607,745. The one-year Total Return for the Long-Term Endowment Portfolio was 37.7% compared to the Policy Index of 33.3%.

The market value of the Medium-Term Fund portfolio at 3/31/2021 was \$8,850,013. The one-year Total Return for the Medium-Term Endowment Portfolio was 21.4% compared to the Policy Index of 18.2%.

The market value of the ESG Fund portfolio at 3/31/2021 was \$4,529,325. The one-year Total Return for the ESG Portfolio was 30.5% compared to the Policy Index of 30.9%.

The market value of the DRIM Fund portfolio at 3/31/2021 was \$2,599,696. The one-year Total Return for the DRIM Portfolio was 27.5% compared to the Policy Index of 41.1%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$88,552 and total expenses were \$7,839,193, which includes \$7,702,746 in grants from the 2020 Monterey County Gives campaign.
