CALL TO ORDER

Board Chair Teri Belli called the meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:30 PM, Tuesday, August 24, 2021.

CONSENT AGENDA – Teri Belli, Chair

Chair Belli welcomed the board. She thanked the board members for their service on these committees.

Motion: To approve the Consent Agenda as presented. Francine Rodd / Loren Steck second. Motion carried unanimously.

REPORT OF THE CHAIR – Teri Belli

Chair Belli revisited the survey regarding in-person meetings. There have been good discussions in both the Executive Committee and Finance Committee meetings on people's comfort. Several board members have commented that we need to move towards a hybrid model for meetings, but the consensus for now is to continue with zoom meetings.

GOVERNANCE COMMITTEE – Birt Johnson, Jr.

Board member Johnson recognized the committee's diligent work and highlighted Board member Majia West's 4 years on the committee. The committee put much thought into this year's nominating priorities. He stressed two important items the board would need to approve: the recommendation of Board Secretary and the extension of the Board Chair. He listed this year's four departing board members and their skill sets. The committee referenced the updated board matrix for priorities of new board members for 2022-2023. The committee will be looking for four replacements bringing the board to 20 directors (the bylaws allow for 21 board members). The committee set their priorities by skill set: finance/treasurer, advocacy, philanthropy, real estate,

investment, healthcare; geography: South County and Big Sur; age: 30 – 44; and, diversity: retain gender balance, Asian/Pacific Islander, continued emphasis on Latinx and Black and LGBTQ. He stated that not all recommendations need to fall under these categories. He outlined the process and next steps encouraging the board members and staff to forward all request to Dan. The Governance Committee will meet before the Executive Committee's meeting on September 28 to present their nominations and prepare the subsequent recommendation to the board in October. The members may talk to outside agencies for recommendations.

Motion: To approve the recommendation of Kirk Gafill to fill the position of Board Secretary for the remainder of 2021.

Birt Johnson, Jr. / Betsey Pearson second. Motion carried unanimously.

Board member Johnson informed the board of Chair Belli's six years of service completing her second 3-year term. Chair Belli has volunteered to extend her service to complete her second year as chair.

Motion: To approve the extension of Chair Belli's term by one year as board chair. Loren Steck /Joe Pezzini. Motion carried unanimously.

TEASURER / FINANCE COMMITTEE - Jan Vanderbilt

Board member Vanderbilt reviewed the financial statements for June and July 2021. She pointed out that June is a quarter end and highlighted that administrative fees show up on those months. She also pointed board members to look at the complete financials on the portal to see the sources and uses of funds. She referenced the climb in total assets towards four hundred million.

Presenting the operating budget, revenues are exceeding our expectations and expenses are lower than budgeted. Board member Vanderbilt pointed out the discrepancy from the last statement was corrected under the Development, Program and Staff – Advertising & Promotion.

Motion: To accept the financials as presented. Jan Vanderbilt/Judy Guzman Krueger second. Motion carried unanimously.

Board member Vanderbilt laid out the budget timeline. The budget process has started internally and will be presented for review at the October finance meeting and approved at the December board meeting.

PHILANTHROPIC SERVICES COMMITTEE - Betsey Pearson

Board member Pearson praised the philanthropic services team, noting there is usually a summer lull that didn't occur this year. Senior Vice President of Philanthropic Services Christine Dawson explained the development summary, highlighting the level of trust that the P.S. team has created with the public and their continuing building of relationships. Board member Lehman requested a five-minute story about the relationship building in future board meetings. Senior Vice President Dawson shared a quick story regarding the newly created Jett Fighter Fund.

Board member Pearson informed the board of the work in progress around the Celebration of Philanthropy. Senior Vice President Dawson informed the board of the date, Tuesday Oct. 19, from 4-6 p.m. In addressing the shifting Covid environment, in-persons invitations were decreased to 150 people following the recommended protocols with a live streaming invite to everyone. It will be held at Pasadera.

COMMUNITY IMPACT COMMITTEE – Laurel Lee-Alexander (for Betsy Buchalter Adler)

Vice President of Community Impact Laurel Lee-Alexander presented the list of grant approvals requiring ratification by the board.

Motion: To approve 366 grants for a total of \$4,422,327 from June 30 – July 31, 2021. Loren Steck/Kirk Gafill second. Motion carried unanimously.

INVESTMENT COMMITTEE – Giff Lehman

Board member Lehman presented the portfolio report focusing on the long-term fund. He gave the board a quick tutorial on reading the report. Board members asked questions regarding policies, ranges, portfolio makeup and DRIM.

NEW FUNDS – Dan Baldwin

President Baldwin presented the new funds to the board and highlighted the Julie Conrad Donor Advised Fund that was created as a retirement gift for Julie Conrad.

We have been able to achieve this through the DAF process. He was able to answer board questions and clarify our position as a community foundation rather than a commercial provider.

CALL TO ORDER - Teri Belli

Chair Teri Belli called the Zoom meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:30 on September 28, 2021.

REPORT OF THE CHAIR - Teri Belli

Chair Belli apprised the committee of the ongoing work of the staff in preparing for the Celebration of Philanthropy event on October 19, 2021. The in-person participation cap is 150 people and current RSVPs are over 90.

The November Executive Committee date has historically had challenges due to the Thanksgiving holiday. The meeting was previously scheduled for Nov. 16th, however, it is challenging to have the budget ready by that date. All agreed to hold the meeting on Nov. 23rd.

Chair Belli asked the committee about the board DAF education presentation and whether it was valuable time spent. The committee made favorable comments and applauded the efforts of the staff to educate the board. Chair Belli asked President Dan Baldwin to describe the topic that will be presented at the next board meeting on the initiatives that the Community Foundation play a part in. The committee agreed it was essential for the board members to know about these initiatives.

TREASURERS REPORT- Jan Vanderbilt

Board Treasurer Jan Vanderbilt presented a summary of the August financials. She reported the financial statements have not been reviewed by the finance committee and will be approved at the October board meeting. President Baldwin informed the committee that finance committee will be seeing a draft budget at their meeting and Treasurer Vanderbilt met with the finance staff to review the draft and it is looking favorable.

PHILANTHROPIC SERVICES COMMITTEE - Christine Dawson

Senior Vice President of Philanthropic Services Christine Dawson presented the Development Summary for August. She highlighted our year-to-date totals which surpass last years numbers. The pandemic has not slowed things down in resource development. She informed the committee of the launch of the MC Gives campaign on October 6 for the non-profits, and on November 11 for the community.

Senior VP Dawson updated the committee on reengagement professional advisors with the Trends in Planned Giving event next week. The original date of October 23 was amended to the 14th due to a conflict with the estate plan attorneys brown bag lunch.

COMMUNITY IMPACT COMMITTEE

COMMUNITY IMPACT INVESTMENT COMMITTEE - Nolan Kennedy

Board member Nolan Kennedy stated that the existing loans are performing fine. The CHISPA loan was in question with the death of their executive director. President Baldwin has been in communication with the agency. They are moving forward and staying on course. Board member Kennedy stated that the committee is looking to meet in late October to explore their next steps in impact investing.

GOVERNANCE COMMITTEE - Birt Johnson, Jr.

Board member Birt Johnson acknowledged the efforts of the Governance committee and presented their report. There are four board members leaving in 2021. The categories addressed were CPA, advocacy, community, and diversity. The committee has a strong list of candidates, providing more than needed minimizing the committee reconvening if candidates are not able to participate.

Board member Johnson stated that the officer slate for 2022 will also be recommended by the Governance Committee at the October board meeting with confirming vote at the December board meeting.

PRESIDENT/CEO REPORT - Dan Baldwin Staff Updates

President Baldwin informed the board of the recent resignation of Mackenzie Little, Philanthropic Services Officer. She accepted a position as a Director of Donor Services with the Parasol Tahoe Community Foundation in Incline Village, NV.

Reid Norris is joining the CNE team as Leadership Development Specialist beginning September 29. He was the Executive Director of Everyone's Harvest.

We are fully staffed in finance with Kim Drabner as new VP of Finance and Human Resources. Brian Erbele comes from the United Way and is our new Director of Finance. Gianna Yim is our new accountant and Sarah Elias is our accounting coordinator. This is Diane Nonella's last meeting as she is retiring October 1. The committee thanked her for her service to the Foundation.

With the Foundations growth over the years, the communications department is needing to expand. Currently staffing is a full time Director of Communications and a part time Communications Coordinator. We will be increasing the Communications Coordinator position to full time and recruitment is happening. These positions have been built into the 2022 budget.

DEI – League of California Community Foundations Committee

President Baldwin informed the committee of the LCCF's opportunities for board members of community foundations to participate in DEI workshops and engage with other DEI workgroups. These are good, informative sessions to glean best practices and new ideas for the work we are doing.

Board of Supervisors COVID-19 approval of Funds for VIDA Project

President Baldwin reported that the Board of Supervisors approved \$950,000 to extend the VIDA program. He applauded Michael Castro, our Community Initiatives Manager, and Dr. Krista Hanni of the County Health Department. Vice President of Community Impact Laurel Lee-Alexander said the CFMC received many compliments from the Board of Supervisors and members of the public for our role in VIDA and the COVID 19 Collaborative.

President Baldwin wanted to inform the board that there was a past board chairs event and shared how they are still engaged.

Finance Committee Minutes August 24, 2021

The meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Jan Vanderbilt, CPA at 2:02 p.m. The meeting was conducted via Zoom.

Action Items

Minutes

Jan called for a motion to approve the June 2021 meeting minutes as there were no questions or requested revisions.

Motion: Birt Johnson made a motion to accept the minutes as presented, with a second from Jan Vanderbilt, CPA. The motion passed unanimously.

Financial Statement Review

The June 2021 and July 2021 financial statements were reviewed. As June was a quarter end, the statement was reviewed to highlight the quarterly fees.

Dan noted that there are currently 12.7 months of operating cash. The amount is positively impacted by the quarterly administrative fees. He also noted that the quarterly statement includes the List of Funds showing all funds with the activity for the quarter. The list is not part of the Board packet but is available for review in the complete financial statement on the Board portal.

Jan then moved to the July 2021 financial statements. She pointed out the increase in net assets. The contributions were also noted with Dan reminding attendees that the July 2020 number includes a stewardship addition of approximately \$12.5m. In addition, the grants amount of \$23m as of July 31st was compared to the total 2020 record-setting grant expenditure amount of approximately \$27m.

Jan pointed out that the forgiven PPP loan amount of \$411,402 has been moved to the bottom of the financial statements as a one-time extraordinary item that is now accounted for under "Other Income".

The committee had a discussion about the current surplus status. It was noted that investments in staff are being made through the addition of needed positions that will impact the budget status going forward. In addition, the benefit of a surplus for future needs and internal investment was discussed.

Motion: Teri Belli made motion to approve the financial statements as of June 30, 2021 and July 31, 2021, with a second by Birt Johnson, Jr. The motion passed unanimously.

Budget Timeline

Dan gave an overview of the budget process. A first draft of the budget will be presented to Jan prior to the October meeting for an opportunity for input and discussion. The budget will then be presented to the committee in October.

Comparisons of Actual to Budget - Operating Fund

Assets

Total Assets through 8/31/2021 are \$373,305,043 a 23.79% increase since August 2020 and a 7.16% increase since December 2020. (p. 3)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. In August, Jean Duff established a \$75,000 CGA for the benefit of Margaret Ganopole. The remainder value is calculated at \$46,124.25 and will add to the Jean and Jim Duff Fund. Robert Haas established his 10th CGA with \$65,000. The remainder value is calculated at \$27,662.70 for the benefit of the Operating Fund. (p. 5)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$5,421, and unrealized gains were \$30,816,694, for a total gain of \$30,822,115. (p. 6)

Operating Fund

Total revenue was \$243,321 more than the budget, and total expenses were \$241,022 less than the budget. Unrealized gains were \$24,316 on the operating reserve held in the Medium-Term Fund portfolio and realized gains were \$5 on a stock gift to the operating fund. The PPP loan forgiveness is reflected as Other Income contributing to an actual net operating surplus of \$460,705 compared to a budgeted deficit of \$459,126. (p. 7)

Note: The Expendable Operating Cash-on-Hand is at 9.4 months, excluding the operating reserve of \$500,000, the building reserve of \$150,000, and includes the PPP Loan, which was fully forgiven March 31, 2021.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 8/31/2021 was \$311,665,273. The one-year Total Return for the Long-Term Endowment Portfolio was 21.8% compared to the Policy Index of 19.1%.

The market value of the Medium-Term Fund portfolio at 8/31/2021 was \$9,803,041. The one-year Total Return for the Medium-Term Endowment Portfolio was 10.9% compared to the Policy Index of 9.7%.

The market value of the ESG Fund portfolio at 8/31/2021 was \$5,705,660. The one-year Total Return for the ESG Portfolio was 17.2% compared to the Policy Index of 17.4%.

The market value of the DRIM Fund portfolio at 8/31/2021 was \$3,655,913. The one-year Total Return for the DRIM Portfolio was 29.3% compared to the Policy Index of 63.7%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$3,371,321 and total expenses were \$8,687,436, which includes \$7,702,746 in grants from the 2020 Monterey County Gives campaign. (p. 5-6)

Quarterly Sources and Uses

Assets

Total Assets through 9/30/2021 are \$361,022,368 a 21.75% increase since September 2020 and a 3.63% increase since December 2020. (p. 3)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2020. In September, the Perry Miller CRT terminated with a remainder value of \$1,027,059 which established an endowed fund. (p. 5)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$3,898, and unrealized gains were \$20,105,765, for a total gain of \$20,109,663. (p. 6)

Operating Fund

Total revenue was \$332,224 more than the budget, and total expenses were \$206,862 less than the budget. Unrealized gains were \$8,545 on the operating reserve held in the Medium-Term Fund portfolio and realized gains were \$5 on a stock gift to the operating fund. The PPP loan forgiveness is reflected as Other Income contributing to an actual net operating surplus of \$958,774 compared to a budgeted surplus of \$89,063. (p. 7)

Note: The Expendable Operating Cash-on-Hand is at 12.2 months, excluding the operating reserve of \$500,000, the building reserve of \$150,000, and includes the PPP Loan, which was fully forgiven March 31, 2021.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 9/30/2021 was \$300,422,330. The one-year Total Return for the Long-Term Endowment Portfolio was 20.7% compared to the Policy Index of 18.6%.

The market value of the Medium-Term Fund portfolio at 9/30/2021 was \$9,626,461. The one-year Total Return for the Medium-Term Endowment Portfolio was 9.9% compared to the Policy Index of 8.9%.

The market value of the ESG Fund portfolio at 9/30/2021 was \$5,589,389. The one-year Total Return for the ESG Portfolio was 16.1% compared to the Policy Index of 16.6%.

The market value of the DRIM Fund portfolio at 9/30/2021 was \$3,461,407. The one-year Total Return for the DRIM Portfolio was 28.5% compared to the Policy Index of 59.5%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$3,390,665 and total expenses were \$8,798,401, which includes \$7,702,746 in grants from the 2020 Monterey County Gives campaign. (p. 5-6)
