## Three Grant Programs by Comparison



## Suggestions for Submitting the Strongest Community Impact Proposal Possible

#### SELECTING GRANTS

- Align with one or more Community Impact funding priorities
- Submit a proposal and budget taking into account the grant period. Larger grants will have a grant period from July through next May. (<\$15k June - April)</li>
- ✓ Propose SMART goals
  - Specific, Measurable, Achievable, Relevant, Time-bound

#### Organizational Development – New for 2022

| Before                                     | Effective beginning in 2022  |
|--|--|
| \$1,000 - \$5,000                          | \$1,000 - \$10,000   |
| Staff wages/salary not an eligible expense | Staff wages/salary may be<br>eligible for time directly<br>related to the OD project |
| N/A  | Special consideration for efforts to strengthen and rebuild due to COVID             |

- Persuasively show how the funded activities will contribute to a significant shift or improvement in your organization



## Suggestions for Submitting the Strongest Opportunity Proposal Possible

- Opportunity Grants support two basic scenarios
  - New efforts
  - Time-sensitive (unexpected)
- Consider the time frame of your application and plan accordingly
- ✓ Well thought out applications describing the community need, with data if available
