CALL TO ORDER

Board Chair Teri Belli called the meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:32 p.m., Tuesday, June 28, 2022.

Chair Belli welcomed the board. Chair Belli asked the board if they had any questions or concerns related to the consent agenda.

REPORT OF THE CHAIR – Teri Belli

Chair Belli shared her experience at the League of California Community Foundations CEO/Board Chair retreat. She conveyed that community foundations’ priority is focused on community leadership.

- Organizational Excellence – Optimize performance and stewardship for maximum impact

Chair Belli confirmed the DEI workgroup's discussion to have a DEI training for the board sometime in September.

Chair Belli announced that after the presentation of the Safe, Affordable, Quality Childcare Act ballot initiative, the board will vote whether to endorse the initiative.

Chair Belli presented the Executive Committee's recommendation of Bruce Taylor for the 2022 Distinguished Trustee Award. President Dan Baldwin spoke to Bruce Taylor's commitment to the community and the philanthropic legacy of the Taylor family.

Motion: To nominate Bruce Taylor for the 2022 Distinguished Trustee Award. Betsey Pearson / Judy Guzman Krueger second. Motion carried unanimously.

Joe Pezzini abstained.

TREASURER / FINANCE COMMITTEE – Jan Vanderbilt

Treasurer Jan Vanderbilt presented the financial reports for April 30, 2022, and May 31, 2022. She pointed out that the variances are attributed to the volatility of the stock market.

Motion: To approve the April/May 2022 financials as presented. Jan Vanderbilt / Jennifer Walker second. Motion carried unanimously.

COMMUNITY IMPACT INVESTMENT COMMITTEE – Nolan Kennedy

Board member Nolan Kennedy shared two items. The Committee approved a year extension for the draw period on the CHISPA loan. Their second draw will be \$8,100, leaving \$95,000 outstanding.

The United Way loan was approved, papers were signed, and it is now in escrow. Escrow should close on their building by Friday, July 1, 2022.

Board member Kennedy informed the board of the committee's next steps in having a planning session for future direction and will report back.

INVESTMENT COMMITTEE – Giff Lehman

Board member Giff Lehman gave an update on the performance of the CFMC's investment portfolios. The long-term portfolio is down \$37 million from last year. There was discussion regarding the movement of the market. He stated CFMC has a broadly diversified investment portfolio to assist with the fluctuations.

COMMUNITY IMPACT – Adriana Melgoza

Board member Adriana Melgoza presented to the board two items for approval.

The grant approvals for April 1, 2022 to May 31, 2022.

Motion: To ratify 203 grants for a total of \$1,853,797.03 from April 01, 2022 – May 31, 2022.

Adriana Melgoza / Tyller Williamson second. Motion carried unanimously.

Board member Melgoza recognized the two sub-committees' chairs, Board members Francine Rodd and Romero Jalomo, thanking them for their service. She presented this year's Community Impact grant recommendations.

Motion: To approve the Community Impact grants as recommendation by the two Community Impact grant sub-committees totaling \$2,156,512; 62 grants totaling \$1,740,000; 23 small CI grant totaling \$241,512; 7 renewal grants totaling \$175,000.

Francine Rodd / Joe Pezzini second. Motion carried unanimously.

PHILANTHROPIC SERVICES – Betsey Pearson

Board member Betsey Pearson pointed out the philanthropic services report in the packet and all the work that is being done.

She asked board members to mark their calendars for the Celebration of Philanthropy, October 5th at Pasadera from 4 p.m. to 6 p.m.

She presented an updated Gift Acceptance Policy for board approval. She briefly described the changes in title updates, inclusion of the Fund for Monterey County, charitable gift annuity updates, and the inclusion of crypto currency. She stated that the Silicon Valley Community Foundation will be the back office for crypto currency processing. A correction was noted on page 62 to read, “The foundation’s board has the ability to make changes.”

Motion: To approve the recommendation of the Philanthropic Services Committee updated Gift Acceptance Policy with correction.

Betsey Pearson / Larry Oda second. Motion carried unanimously.

PRESENTATION (Safe, Affordable, Quality Childcare Act ballot initiative)

President Baldwin gave a brief introduction of the initiative. Referenced a conflict-of-interest issue with First 5 Monterey County being part of the initiative. Board member Rodd, Executive Director of First 5 Monterey County, would recuse herself from the presentation, board discussion and vote.

Board member Rodd removed herself from the meeting at 4:24 PM.

President Baldwin introduced Julie Drezner and Kevin Dayton. After giving their brief histories, Drezner gave a PowerPoint outlining the measure’s tax mechanism, the reason for this measure, and how the funds generated would be administrated. Dayton assured the fiscal accountability. The measure is a ballot initiative that includes a \$49 annual parcel tax. There was extensive discussion.

The presenters were excused at 5:20 pm.

Board discussed at length and revisited the advocacy guidelines.

June 28, 2022**

The meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Jan Vanderbilt at 2:00 p.m. The meeting was conducted via Zoom.

Action Items

Minutes

Jan called for a motion to approve the April 26th meeting minutes.

Motion: Joe Pezzini made a motion to accept the meeting minutes, with a second from Kirk Gafill. The motion passed unanimously.

Financial Statement Review

The April 2022 and May 2022 financial statements were presented and reviewed. Dan noted that CFMC is still in a good position despite the unrealized losses in the market and that December 31, 2021 was a high water mark for total assets. The committee fully discussed the subject.

Jan then directed the committee to the May 2022 operating revenue and expenses versus budget. It was mentioned that the line item for Consulting/Legal Services is over budget. Dan informed the committee that this was primarily due to consulting services from Diane Nonella assisting in the finance department. The other line item over budget that was mentioned was utilities. Kim Drabner investigated the variance and noted that the budget calculation for utilities was understated, causing the large variance.

It was pointed out that the cash reserves listed on the financial statements is 8.1 months, but the notes to the financials section indicates 8.6 months. Kim confirmed that the correct number is 8.1 months and will update the financials accordingly.

Motion: Jan Vanderbilt made a motion to approve the financial statements as of April 30, 2022, and May 31, 2022, with the correction to cash on hand reflected as 8.1 months. Kirk Gafill seconded the motion. The motion passed unanimously.

Jesse Lopez joined the committee meeting at 3:32 p.m.

Banking RFP Draft

Kim presented the RFP Draft and thanked David Warner for help. The committee discussed the draft regarding bank qualifications and location requirements. It was decided that the bank must be located in Monterey County.

The committee then agreed to establish a sub-committee to work with Kim on the RFP process and selecting the bank to recommend to the committee. David Warner, Kirk Gafill, and Jesse Lopez all volunteered to be members of the sub-committee. Kim Drabner will coordinate with them on next steps.

Special Project: Equity Fellow

Dan presented a concept in the early planning stages for a new, time-limited position to increase CFMC's impact in the community. It would be a two-year position costing approximately \$248,000 in total. The Equity Fellow position will be brought up in the August 23 committee meeting. Dan emphasized that the downturn in the market and fund balances might make this a difficult time to create this position.

The special meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Jan Vanderbilt at 2:13PM on August 16, 2022. The meeting was conducted via Zoom.

2021 Form 990 Review

Ms. Said presented the 2021 Form 990. Items of note were:

- Statement of Program Service Accomplishments – lists the top three (3) accomplishments of the Foundation based on program expenses.
- Schedule of Contributors (Schedule B) – Ms. Said reiterated that this schedule is part of the filing document but is removed for public presentation.
- Ms. Said responded to Joe Pezzini’s question of what is considered public support. Ms. Said noted that the amount refers to contributions, and not any revenue from investments, or any revenue from sources not related to the mission of the CFMC.
- It was mentioned that the \$4.9MM grant from County of Monterey for the VIDA project should be listed in Part VIII line 1e instead of Part VIII line 1f. Ms. Said confirmed this will be updated.
- Dan noted that Christine Dawson’s title needed to be updated to Senior Vice President of Philanthropy for Part VII on the 990 and Part II on Schedule J. Kim Said confirmed this will be updated.

With no further questions on the document, Kim Said, CPA left the meeting.

Motion: Jan Vanderbilt made a motion to accept the Form 990 with the correction that line 1e of Part VIII includes the County of Monterey Grant and to update Christine Dawson’s title on the Form 990 Part VII as well as Part II on Schedule J. The motion was seconded by Kirk Gafill, and the motion passed unanimously.

Investment Committee Minutes August 8, 2022

The regular meeting of the Investment Committee of the Community Foundation for Monterey County was called to order by Giff Lehman at 3:03 PM on August 8, 2022. The meeting was conducted via Zoom.

Minutes

On a motion by Loren Steck, with a second from Giff Lehman, the May 09, 2022 minutes were approved as written.

Verus Performance Review

Anne presented the Performance Report for the Long Term Portfolio, Medium Term Portfolio, ESG Portfolio, and DRIM. The second quarter 2022 investment results were reviewed.

The committee discussed in detail the performance and benchmarks of the domestic equity holding T. Rowe Price Large-Cap Growth Fund – I Class. Bill Sharpe noted that the committee may want to consider using a different index (Russell 1000 Growth Index) to compare against that holding. The topic was fully discussed.

The committee also discussed the difference of active fund management Vs. passive fund management. Giff Lehman noted that he would like to review the alpha of the active fund managers to understand more about why we would choose a particular fund manager for a holding.

Anne indicated that Verus would research continuing to use the Russell 1000 Growth Index as a benchmark against the T. Rowe Price Large-Cap Growth Fund – I Class and continue the conversation regarding active manager funds within the long-term investment portfolio.

YTD Performance

The market value of the Long-Term portfolio at 06/30/2022 was \$262,779,027. The YTD returns were -15.6% compared to the policy benchmark of -14.5%.

The market value of the Medium-Term portfolio at 06/30/2022 was \$9,202,700. The YTD returns were -13.1% compared to the policy benchmark of -12.7%.

The market value of the ESG portfolio at 06/30/2022 was \$6,156,625. The YTD returns were -15.0% compared to the policy benchmark of -16.2%.

Active Manager Presentation

Equity Regional Allocation Philosophy

Anne presented CFMC's current asset allocation against the investment policy of the three investment portfolios (long-term, medium, ESG).

CFMC's equity allocation philosophy for each of the three investment portfolios were discussed and Anne recommended that the investment holdings should have more consistency in allocation of domestic and international holdings. Joe Abdou presented what allocations would change between domestic equities, developed international equities, and emerging markets. It was noted that the total equity allocation would not change.

The committee discussed the subject regarding emerging market allocations within the equity allocation philosophy. The committee agreed to use the MSCI ACWI to use as a starting point for updating the equity regional allocation along with a policy statement reflective of the emerging market allocation in equities.

Asset allocation review

Joe Abdou presented the CFMC's current asset allocation in terms of risk tolerance. Joe provided scenario analysis if CFMC invested in private equity to increase returns as a possibility. The scenario analysis showed the 10-year forecast for stagflation, weak, base CMA, and strong scenarios among each of the investment pools.

The committee discussed asset allocation to keep in mind prior to the spending policy discussion for next meeting.

Real Asset Outlook

Anne presented the outlook on real assets. Anne noted that the summary indicates neutral position on all real asset classes except for value-add infrastructure, which is a positive outlook.

Anne also noted the growth in alternative property types illustrate the change in the composition of the REIT market and the private core real estate market. This conversation led to the Harrison Street recommendation line item on the agenda.

Harrison Street recommendation

Anne recommended adding the \$5MM of the Harrison Street real estate holding. Bill Doolittle asked where the money was going to be taken from. Anne noted that the money would come pro-rata from wherever the portfolio is overweight. It would be supplementary of the ASB holding. The Harrison Street holding would provide more diversification for the overall real estate performance. The committee discussed the recommendation.

Action item: Loren Steck motioned to approve purchasing Harrison Street to the portfolio for \$5MM by reducing the assets the portfolio is overweight on a pro-rata basis. Giff Lehman seconded the motion and it was passed unanimously.

Attributes to Committee Chair

Dan Baldwin reminded the committee that Giff would be terming off as the chair of the committee at the end of 2024 and began the discussion of what attributes the committee would like to see in the next committee chair. Dan noted that the plan would be to bring someone on to the committee prior to making someone a committee chair for 2025.

It was noted that the next committee chair should have the following initial attributes:

- Must be a board member for CFMC
- Have strong professional financial advising or investment market expertise

The committee offered to begin reaching out to potential candidates to join the committee and identify possible committee chair candidates.

Having no further business, the meeting was adjourned by Giff Lehman at 5:03 PM.

Community Impact Investment Committee Minutes July 28, 2022

Present: Nolan Kennedy, Chair, Loren Steck, Giff Lehman, Kirk Gafill, and Tyller Williamson

The Community Impact Investment Committee of the Community Foundation for Monterey County was called to order by Nolan Kennedy at 3:05 PM.

Discussion Items

Nolan turned the discussion to Dan. Dan noted that Nolan, founding Chair of the Committee is rotating off the board and Loren Steck will be the next Community Impact Investing Committee chair.

CII Portfolio Report

Dan reviewed the CII portfolio report prepared by Community Capital Advisors. A review of current loan holders, amounts outstanding, and loan functions took place. It was noted that loans for both CA Farm Link and Opportunity Fund both come due in December 2023.

CII Investment Policy

Dan presented the target capacity for investment in CII activities, which is based on CFMC total assets. It was demonstrated that the CII policy has a 2% investment target, which equals approximately \$6MM. The range of this target can go up to 5% or \$15MM. The committee then reviewed available investment capacity with the current Sun Street Centers loan request in mind.

Dan then reviewed CIIC's investing allocation:

- CDFI – \$2.5MM
- Real Estate/Affordable Housing - \$250k
- Non profit loans - \$1MM

With the CI Capacity and Allocation reviewed, the following points were noted:

- Is there an ideal allocation?
- Loan program could very likely grow.
- Real estate loans might require larger sums.
- How proactive do we need to be?

The topic of CIIC investment policy, capacity, and allocation was fully discussed.

Sun Street Centers Loan Request

Dan presented the background for the Sun Street Centers loan request of \$1.3MM for the purpose of supplementing building costs for a recovery center on a property Sun Street Centers already owns. It was indicated that Sun Street Centers were planning on not using any loans for the building costs, instead using capital campaign gifts and grant revenue sources. However in order for Sun Street to obtain one key grant meant for this project, Sun Street Centers needs to have all financing in place at time of application submission. This CII loan would allow Sun Street Centers to be eligible for the key grant. It was also noted that a 'Letter of Intent' from CFMC for \$1.3MM would be sufficient for Sun Street Centers' grant application.

Daniel Faith, Director of Finance, reviewed Sun Street Centers' past four fiscal years of audited financials and tax returns and compiled the financial metrics on a one-page summary distributed to the committee. The committee reviewed the summary and discussed the subject fully.

Kirk recommended that committee members with banking expertise should review the loan request along with the financial metrics as part of the committee's due diligence. Dan and Nolan confirmed that they will meet with Rich Aiello and Bill Tebbe.

Action Item

Nolan Kennedy or Kirk Gafill made a motion to establish a subcommittee comprised of Dan Baldwin, Nolan Kennedy, and Loren Steck with the authority to approve the loan subject to the following terms:

- \$1,300,000
- 3.5% interest
- 5 year term with option to renew for an additional 5 years amortized over 25 years
- Interest only for first year
- Funding contingent on Sun Street being awarded the large key grant
- Further due diligence with Rich and Bill

The motion was seconded by Loren Steck and passed unanimously.

It was noted that the sub-committee, Rich Aiello, Bill Tebbe, Kim Drabner, Daniel Faith, and Anna Foglia from Sun Street Centers will meet the following week to discuss the loan request further.

CII Opportunities

Dan opened a discussion on future CII opportunities by category:

- Housing
 - CHISPA
 - MidPen Housing (City of Monterey)
 - New Way Homes – Salinas
- Loans
 - Sun Street Centers loan – in process
 - CHS (Shuman HeartHouse) – Capital campaign is underway
- Other
 - Granny unit low interest loans – would require advertising
 - Participation with developers (i.e. Seaside) with emphasis on affordability

Within the context of Community Impact Investing, Dan laid out three key funding strategies:

- 1) Asset Allocation – CFMC's current funding type,
- 2) Separate pool of raised funds – Risk is this could compete with grantees
- 3) Donor Advised Funds

The committee discussed the pros, cons, and general requirements of each strategy.

Having no further business, the meeting was adjourned 5:10 PM.

Other considerations are health care, hospitality, secondary education, business, and representation specific to Seaside/Marina.
3. The committee had a preliminary discussion about 2023 officers.
4. Dan Baldwin gave an update on the status of revising the board member job description/expectations, officer job descriptions and the bylaws. These will be addressed at the final meeting of the year.

Endowment Stewardship Committee Minutes of the July 18, 2022 Meeting

Call to Order: The regular meeting of the Endowment Stewardship Committee of the Community Foundation for Monterey County (CFMC) was called to order at 2:15 p.m. by Betsey Pearson. The meeting was held via zoom conference call.

Update

1. Janet provided an update on the committee's questions from the November 2021 meeting. The committee agreed with the provided responses.
 - a) Community Homeless Solutions confirmed that it would like the fund name of the restricted endowment benefitting its organization to be updated to reflect the organization's current name. The fund name was changed from Shelter Outreach Plus Fund to Community Homeless Solutions Fund.
 - b) Staff contacted Mexican American Opportunity (MAOF) about Children's Services International Fund, the fund name of the restricted endowment benefitting its organization. Staff is waiting for MAOF's response.
 - c) The committee understands that the Patricia J. Boles Fund supported two grants in 2010 that did not directly support arts programming or arts education. Staff have since implemented a new process with additional measures to prevent such errors from happening.

Approval of minutes: Motion: Elsa Mendoza Jimenez / second Betsey Pearson; motion carried.

Fund Review

2. Committee members reviewed fund summaries, grant history and legal agreements of 19 funds. Betsey facilitated the committee's discussion of these funds.

Review Restricted Agency Endowments

1. Health Projects Center Fund – Continue reinvesting annual distribution until the annual distribution level is \$2,000 or until the organization requests otherwise.
2. Monterey Public Library Fund – Continue reinvesting annual distribution unless the organization requests otherwise.
3. Big Sur Health Center Endowment Fund – Continue reinvesting annual distribution.

Dan commented that the Monterey Public Library's Fund has increased considerably because the Library has campaigned to grow its endowment, for example through its annual campaign and Monterey County Gives!

There was no discussion regarding the above funds. Committee agreed with staff's recommendations.

4. Sunset Theater Endowment Fund
 - Recommendation: Continue reinvesting annual distribution unless the organization requests otherwise.

5. Chamber Music Monterey Bay Fund
 - Recommendation: Continue making annual distributions.
6. Tularcitos Parent Teacher Organization Fund
 - Recommendation: Continue making annual distributions.
7. Sylvia W. Schwarz Endowment for Reading Improvement at Tularcitos School
 - The committee noted that both Funds benefitting Tularcitos School did not have distributions in 2009 because the amount was too small after as a result of the 2008 recession.
 - Recommendation: Continue making annual distributions.
8. David Allen Bernahl II, Local Heroes Fund for CASA
 - Discussion: Dan commented that CASA has had five executive directors since this fund was established.
 - Recommendation: Continue making annual distributions and contact CASA to ensure the agency is aware of this fund.
 - For this Fund and all funds in this category, staff to contact organizations approximately every 3-5 years when there have been administrative changes (rather than making the assumption that the organization would want to rename its fund. We don't want to impose our view.)
9. Salinas Rodeo Rotary Club Foundation Agency Endowment Fund
 - Recommendation: Continue making annual distributions.

Committee agreed with the above recommendations.

Motion: Jennifer Walker / second Elsa Mendoza Jimenez; motion carried.

Designated Agency Endowments

10. Jane P. McKay Endowment Fund for the Big Sur Land Trust Fellowship Program
 - Recommendation: Continue making annual distributions.
11. Jane P. McKay Endowment Fund for Door to Hope
 - Recommendation: Continue making annual distributions.
12. Jane P. McKay Endowment Fund for the Hartnell College Foundation Counselors' Grants Program
 - Recommendation: Continue making annual distributions.
13. Central Coast Lighthouse Keepers Fund
 - Dan explained that this Fund's annual distributions increased noticeably in 2017 after receiving a \$497,000 planned gift.
 - Recommendation: Continue making annual distributions.

Committee agreed with the above recommendations.

Restricted Scholarship

14. Hausdorf Family Scholarship Fund
 - It was noted that multiple scholarships were awarded to the same student because this is a renewable scholarship.
 - Recommendation: Continue making annual scholarships.

15. Dr. Gladys M. Olvis Scholarship Fund

- The committee noted that no award was made in 2019 to the Memorial University of Newfoundland, and two were awarded in 2020.
- Recommendation: Continue awarding annual scholarships.

Committee agreed with the above recommendations.

Unrestricted

16. John R. Marron Fund

- Recommendation: Continue using funds for CFMC's competitive grant programs, e.g., Community Impact grants.

Committee agreed with the above recommendation.

Motion: Elsa Mendoza Jimenez / Jennifer Walker second; motion carried.

Field of Interest

17. Good Neighbor Basic Human Needs Fund

- Staff commented that this Fund has a relatively low annual distribution amount. Some years, this was the lead fund constituting more than half of the total grant amount. Other years, this Fund helped round up some grants with a small portion of the total grant amount.
- Recommendation: Continue using annual distributions for CFMC's discretionary grant programs.

18. Gumm Fund for the Performing Arts

- Recommendation: Continue using annual distributions for CFMC's discretionary grants supporting arts organizations.

19. Anita Tarr Turk Fund for Breast Cancer Research

- Discussion: Dan shared that Anita's attorney was Mark Johnson, Johnson, Fantl & Kennifer. Towards the end of her life, Anita asked Mark to retrieve cash she kept at home and in safety deposit boxes. Mark invited Dan to accompany him to the bank since CFMC was the sole beneficiary of Anita's estate. Anita kept separate finances from her husband who passed away two months after Anita.
- Recommendation: Continue awarding annual grants.

Committee agreed with the above recommendations.

Assets

Total Assets through 6/30/2022 are \$322,733,602 a 12.39% decrease since June 2021 and a 16.54% decrease since December 2021. (p. 4)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. (p. 4)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$2,581 and unrealized losses were \$54,211,245, for a total loss of \$54,208,664. (p. 7)

Operating Fund

Total revenue was \$88,849 more than the budget, and total expenses were \$172,365 less than the budget. Unrealized losses were \$99,617 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$7,918 compared to a budgeted deficit of \$169,344. (p. 8)

Revenue continues to be higher than budget through June. However, projections for the third quarter administrative fees based on the June 30 fund balance reflects fees lower than budgeted. Despite this, cash on hand remains steady.

Salaries and benefits continue to be below budgeted amounts. This savings is the result of position vacancies in the first quarter that have now been filled. In addition, while the salary increases related to the Croner salary study have been approved as a budget amendment, additional unbudgeted increases will diminish the savings over time.

Overall administrative expenses continue to be below budget. However, bank charges have trended slightly higher due fees assessed on large credit card donations. Services are significantly higher as a result of the Foundation contracting with former Vice President of Finance, Diane Nonella, to assist in the transition during the Director of Finance recruitment and for additional staff training services.

The 2022 rental agreement for the Salinas property was revised in late 2021. The agreement revised the rent structure to include a utility allocation. As this was completed after the budget process, there is a variance (under) on rent that is offset by a variance (over) on utilities as the agreement shifted the expense classification.

There is an excess actual over budget reflected on the annual report due to timing that will correct in June. Additional staff events have resulted in an actual over budget that is expected to increase prior to the end of the year. Despite this, the development operating actual continues to reflect a surplus over the budgeted amount.

Note: The Expendable Operating Cash-on-Hand is at 9.5 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 6/30/2022 was \$262,779,027. The one-year Total Return for the Long-Term Endowment Portfolio was -12.9% compared to the Policy Index of -10.8%.

The market value of the Medium-Term Fund portfolio at 6/30/2022 was \$9,202,670. The one-year Total Return for the Medium-Term Endowment Portfolio was -12.2% compared to the Policy Index of -11.4%. (

The market value of the ESG Fund portfolio at 6/30/2022 was \$6,156,625. The one-year Total Return for the ESG Portfolio was -12.0% compared to the Policy Index of -13.0%.

The market value of the DRIM Fund portfolio at 6/30/2022 was \$2,675,240. The one-year Total Return for the DRIM Portfolio was x% compared to the Policy Index of -7.7%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the Salinas Inclusive Economic Development Initiative, funded by the James Irvine Foundation; COVID-19 Collaborative support funded by the David and Lucile Packard Foundation; COVID-19 support funded by the Public Health Institute; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$1,124,150 and total expenses were \$11,193,944. This includes grant expense of \$9,493,617 for the 2021 Monterey County Gives campaign. (p. 6-7)

Assets

Total Assets through 7/31/2022 are \$335,244,224 a 10.82% decrease since July 2021 and a 13.30% decrease since December 2021. (p. 4)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. (p. 4)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$2,581 and unrealized losses were \$39,590,781, for a total loss of \$39,588,201. (p. 7)

Operating Fund

Total revenue was \$79,156 more than the budget, and total expenses were \$199,201 less than the budget. Unrealized losses were \$75,878 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$302,295 compared to a budgeted deficit of \$504,574. (p. 8)

Revenue continues to be higher than budget through July. However, projections for the third quarter administrative fees based on the June 30 fund balance reflect fees lower than budgeted resulting in a one month decrease in cash on hand over the three months.

Salaries and benefits continue to be below budgeted amounts. This savings is the result of position vacancies in the first quarter that have now been filled, as well as just over a month of savings on the recent Director of Gift Planning vacancy that will be filled in the first week of September. While the salary increases related to the Croner salary study were approved as a budget amendment, additional unbudgeted salary increases will diminish the salary savings over time. In addition, the renewal of the medical insurance, effective September 1, 2022, was higher than the budgeted expected increase. However, savings through September related to staff members declining coverage that was budgeted will offset the higher cost in the fourth quarter. Overall, salaries and benefits is expected to remain under budget through the end of year.

Overall administrative expenses continue to be below budget. However, bank charges have trended slightly higher due to fees assessed on large credit card donations. Services are significantly higher due to the Foundation contracting with former Vice President of Finance, Diane Nonella, to assist in the transition during the Director of Finance recruitment and for additional staff training services.

The 2022 rental agreement for the Salinas property was revised in late 2021. The agreement revised the rent structure to include a utility allocation. As this was completed after the budget process, there is a variance (under) on rent that is offset by a variance (over) on utilities as the agreement shifted the expense classification.

The annual report came in over budget due to unexpected increases in printing, postage, and design services. The printing service was \$10,057 over budget due to paper and supply chain issues. Staff will evaluate other budget areas for saving potential to offset the overage. The annual meetings expense currently reflects a budget deficit; however, this is related to the timing of payments for the

Celebration of Philanthropy will correct in future months. New hires and other staff life events have resulted in an overage on staff recognition expense. This overage will run through to year end. Despite this, the development operating actual continues to reflect a surplus over the budgeted amount.

Note: The Expendable Operating Cash-on-Hand is at 8.5 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 7/31/2022 was \$275,048,218. The one-year Total Return for the Long-Term Endowment Portfolio was -8.6% compared to the Policy Index of -6.6%.

The market value of the Medium-Term Fund portfolio at 7/31/2022 was \$9527,888. The one-year Total Return for the Medium-Term Endowment Portfolio was -9.7% compared to the Policy Index of -8.7%.

The market value of the ESG Fund portfolio at 7/31/2022 was \$6,337,040. The one-year Total Return for the ESG Portfolio was -7.8% compared to the Policy Index of -9.4%.

The market value of the DRIM Fund portfolio at 7/31/2022 was \$2,800,701. At 6/30/22, the one-year Total Return for the DRIM Portfolio was -15.1% compared to the Policy Index of -16.3%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the Salinas Inclusive Economic Development Initiative, funded by the James Irvine Foundation; COVID-19 Collaborative support funded by the David and Lucile Packard Foundation; COVID-19 support funded by the Public Health Institute; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$1,496,944 and total expenses were \$12,845,575. This includes grant expense of \$9,493,617 for the 2021 Monterey County Gives campaign. (p. 6-7)



Pooled Endowment Portfolio Asset Allocation






MARKET PORTFOLIO IMPACTS

Pooled Endowment Portfolio Asset Allocation









Pooled Endowment Portfolio Asset Allocation





VERUS CAPITAL MARKETS UPDATE

THE ECONOMIC CLIMATE

- U.S. GDP declined at a quarterly annualized rate of -0.9% in Q2 and marked a second consecutive quarter of negative GDP growth. Two consecutive quarters of negative real GDP growth is often viewed as a simple technical definition of recession. However, the official definition is more broad, and many believe the U.S. is not in recession due to continued strength in certain aspects of the economy such as the labor market. This debate will likely continue as investors watch for a positive Q3 GDP figure and monitor trends in employment.

- U.S. headline inflation registered +0.0% month-over-month in July as falling gasoline prices offset rising prices in the food and shelter components. Year-over-year headline inflation measured +8.5%, cooler than the expected +8.7% print, and represented a substantial decrease from June's +9.1% print. This surprisingly weak inflation print fueled optimism that inflation may have peaked and could begin falling from elevated levels.

MARKET PORTFOLIO IMPACTS

- The S&P 500 Index rallied +9.2% in July and reversed June losses as growth equities regained ground alongside falling bond yields.

Introduction

The company has adopted this Plan effective July 01, 2022. Its purpose is to provide benefits for those Employees who shall qualify hereunder and their Dependents and beneficiaries. The concept of this Plan is to allow Employees to elect between cash compensation or certain nontaxable benefit options as they desire. The Plan shall be known as the Community Foundation for Monterey County Premium Only Plan (the "Plan").

I. Article - Definitions

01. **"Administrator"** means the individual(s) or corporation appointed by the Employer to carry out the administration of the Plan. The Employer shall be empowered to appoint and remove the Administrator from time to time as it deems necessary for the proper administration of the plan. In the event an Administrator has not been appointed, or resigns from an appointment, the Employer shall be deemed to be the Administrator.
02. **"Benefit"** means any of the optional benefit choices available to a Participant as outlined in the Section titled: "Benefit Options".
03. **"Code"** means Section 125 of the Internal Revenue Code of 1986, as amended or replaced from time to time, and any governing regulations or applicable guidance thereunder.
04. **"Compensation"** means the total cash remuneration received by the Participant from the Employer during a Plan Year, prior to any reductions pursuant to an Election to Participate form authorized hereunder.
05. **"Dependent"** means any individual who is so defined under an Insurance Contract or who is (i) a Qualifying Child (within the meaning of Code Section 152(c), subject to the exceptions of Code Section 152(b)) or Participant's child (within the meaning of Code Section 152(f)(1)) who has not attained age 27 as of the end of the taxable year, or (ii) a Qualifying Relative who qualifies as a dependent under an Insurance Contract or under (within the meaning of Code Section 152(d), subject to the exceptions of Code Section 152(b)) (as modified by Code Section 105(b)), as applicable. Certain provisions of "Michelle's Law," in which the requirement that a Dependent child have a full-time status in order to extend coverage past a stated age, will generally not apply if the child's failure to maintain full-time status is due to a medically necessary leave of absence or other change in enrollment (such as a reduction of hours). Notwithstanding anything in the Plan to the contrary, the Plan will comply with Michelle's Law.
06. **"Effective Date"** means the effective date of the Plan which is July 01, 2022.
07. **"Election Period"** means the period immediately preceding the beginning of each Plan Year established by the Administrator for the election of Benefits and Salary Redirections, such period to be applied on a uniform and nondiscriminatory basis for all Employees and Participants. However, an Employee's initial Election Period shall be determined pursuant to the Section titled: "Initial Elections".
08. **"Eligible Employee"** means any Employee who has satisfied the provisions of the Section titled: "Eligibility". However, 2% shareholders as defined under Code Section 1372(b) and self-employed individuals as defined under Code Section 401(c) shall not be eligible to participate in this Plan. An individual shall not be an "Eligible Employee" if such individual is not reported on the payroll records of the Employer as a common law employee. In particular, it is expressly intended that individuals not treated as common law employees by the Employer on its payroll records are not "Eligible Employees" and are excluded from Plan participation even if a court or administrative agency determines that such individuals are common law employees and not independent contractors.
09. **"Employee"** means any person who is employed by the Employer, but generally excludes any person who is employed as an independent contractor and any person who is considered self-employed under Code Section 401(c), as well as any person who is a greater than two percent (2%) shareholder in a Subchapter S corporation, a partner in a partnership or an owner or member of a limited liability company that elects partnership status on its tax return. The term Employee shall include leased employees within the meaning of Code Section 414(n)(2), unless excluded by the terms of an Insurance Contract.
10. **"Employer"** means the Non-Profit Organization or any such entity specified in Item 1 of the Adoption Agreement, and any Affiliated Employer (as defined in the Article titled: "Definitions"), that adopts this Plan; and any successor, that maintain this Plan; and any predecessor that has maintained this Plan.
11. **"Highly Compensated Employee"** means, for the purposes of determining discrimination, an Employee so described in Code Section 125 and the Treasury Regulations thereunder.

12. **"Insurance Contract"** means any contract issued by an Insurer underwriting a Benefit, or any self-funded arrangement providing any Benefit offered for health and welfare coverage to Eligible Employees of the Employer.
13. **"Insurance Premium Payment Plan"** means the plan of benefits contained in the Section titled: "Benefit Options" of this Plan, that provides for the payment of Premium Expenses.
14. **"Insurer"** means any insurance company that underwrites a Benefit or any self-funded arrangement under this Plan.
15. **"Key Employee"** means an employee defined in Code Section 416(i)(1) and the Treasury regulations there under.
16. **"Participant"** means any Eligible Employee who elects to become a Participant pursuant to the Section titled: "Application to Participate" and has not for any reason become ineligible to participate further in the Plan.
17. **"Plan"** means the Section 125 Premium Only Plan described in this instrument, including all amendments thereto.
18. **"Plan Year"** means the 12-month period beginning and ending on the dates specified in the Adoption Agreement. The Plan Year shall be the coverage period for the Benefits provided for under this Plan. In the event a Participant commences participation during a Plan Year, then the initial coverage period shall be that portion of the Plan Year commencing on such Participant's date of entry and ending on the last day of such Plan Year.
19. **"Premium Expenses"** or **"Premiums"** mean the Participant's cost for the insured Benefits described in the Section titled: "Benefit Options".
20. **"Regulations"** means either temporary, proposed or final regulations, as applicable, issued from the Department of Treasury, as well as any guidance or interpretations issued in connection therewith.
21. **"Salary Redirection"** means the contributions made by the Employer on behalf of Participants in accordance with the Section titled: "Salary Redirection". These contributions shall be allocated to the funds or accounts established for cost of applicable Benefits provided under the Plan pursuant to the Participants' elections made under the Article titled: "Participant Elections".
22. **"Spouse"** means "spouse" as defined in an Insurance Contract, then, for purposes of coverage under that Insurance Contract only, "spouse" shall have the meaning stated in the Insurance Contract. In all other cases, "spouse" shall have the meaning stated under applicable federal or state law.
23. **"Uniformed Services"** means the Armed Forces, the Army National Guard, and the Air National Guard when engaged in active duty for training, inactive duty training, or full-time National Guard duty, the commissioned corps of the Public Health Service, and any other category of persons designated by the President of the United States in time of war or emergency.

All other defined terms in this Plan shall have the meanings specified in the various Articles of the Plan in which they appear.

II. Article - Participation

01. Eligibility

As to each Benefit provided hereunder, any Eligible Employee shall be eligible to participate as of the date he or she satisfies the eligibility conditions set forth in the policy or plan providing such Benefit (the "Eligibility Requirements"), the provisions of which are specifically incorporated herein by reference.

02. Effective Date of Participation

(a) An Eligible Employee shall become a Participant effective as of the later of the date on which he or she satisfies the Eligibility Requirements of the Plan or the Effective Date of this Plan.

(b) If an Eligible Employee terminates employment after commencing participation in the Plan, except as otherwise provided in the applicable policy or plan providing a Benefit, and such terminated Eligible Employee is rehired within 30 days or less of the date of termination of employment, such rehired Eligible Employee shall not be considered a newly eligible employee and will be reinstated with the same election(s) such individual had before termination. If a terminated Eligible Employee is rehired more than 30 days following termination of employment and is otherwise eligible to participate in the Plan, the individual shall be treated as a newly Eligible Employee and may make a new election under procedures otherwise set forth within this section or the Section titled: "Initial Elections" below as applicable.

03. Application to Participate

An Employee who is eligible to participate in this Plan may, during the applicable Election Period, complete an Election to Participate form that the Administrator shall furnish to the Employee. The Election to Participate form is an irrevocable election made by the Employee to redirect and reduce taxable compensation to cover the Employee's applicable cost of Benefits elected, which shall be applicable until the end of the current Plan Year, unless the Participant is entitled to change his or her Benefit elections pursuant to the Section titled: "Change of Elections".

Such election shall be effective for the first pay period beginning on or after the Employee's effective date of participation pursuant to the Section titled: "Effective Date of Participation".

04. Termination of Participation

A Participant shall no longer participate in this Plan upon the occurrence of any of the following events: (a) His or her termination of employment, subject to the provisions of the Section titled: "Termination of Employment"; (b) His or her death; or (c) The termination of this Plan, subject to the provisions of the Section titled: "Termination".

05. Termination of Employment

If a Participant terminates employment with the Employer for any reason other than death, his or her participation in the Plan shall cease, subject to the Participant's right to continue coverage under any Insurance Contract for which premiums have already been paid.

When an Employee ceases to be a Participant, the cafeteria plan must pay the Employee any amount the Employee previously paid for coverage or Benefits to the extent the previously paid amount relates to the period from the date the Employee ceases to be a Participant through the end of that Plan Year.

III. Article - Contributions to the Plan

01. Salary Redirection

Benefits under the Plan shall be financed by Salary Redirections sufficient to support Benefits that a Participant has elected hereunder and to pay the Participant's Premium Expenses. The salary administration program of the Employer shall allow each Participant to agree to reduce his or her pay during a Plan Year by an amount determined necessary to purchase the elected Benefit and to pay the Participant's Premium Expenses. The amount of such Salary Redirection shall be specified by the Plan Sponsor and shall be applicable for a Plan Year. Notwithstanding the above, for new Participants, the Salary Redirections shall only be applicable from the first day of the pay period following the Employee's entry date up to and including the last day of the Plan Year. These contributions shall be allocated to the funds or accounts established under the Plan pursuant to the Participants' elections made in accordance with the Article titled: "Participant Elections".

Any Salary Redirection shall be determined prior to the beginning of a Plan Year (subject to initial elections pursuant to the Section titled: "Initial Elections") and prior to the end of the Election Period and shall be irrevocable for such Plan Year. However, a Participant may revoke a Benefit election after the Plan Year has commenced and make a new Election to Participate (or decline participation on the Election to Not Participate form) with respect to the remainder of the Plan Year, if both the revocation and the new election are on account of and consistent with a change in status and such other permitted events as determined under the Article titled: "Participant Elections" of the Plan and consistent with the rules and regulations of the Department of the Treasury. Salary Redirection amounts shall be contributed on a pro rata basis for each pay period during the Plan Year. All individual Election forms are deemed to be part of this Plan and incorporated herein by reference.

02. Application of Contributions

As soon as reasonably practical after each payroll period, the Employer shall apply the Salary Redirections to provide the Benefits elected by the affected Participants. Amounts designated for the Participant's Premium Expense Reimbursement Account shall likewise be credited to such account for the purpose of paying Premium Expenses.

03. Periodic Contributions

Notwithstanding the requirement provided above and in other Articles of this Plan that Salary Redirections be contributed to the Plan by the Employer on behalf of an Employee on a level and pro rata basis for each payroll period, the Employer and Administrator may implement a procedure in which Salary Redirections are contributed throughout the Plan Year on a periodic basis that is not pro rata for each payroll period. In the event Salary Redirections are not made on a pro rata basis, upon termination of participation, a Participant may be entitled to a refund of such Salary Redirections pursuant to the Section titled: "Termination of Employment".

IV. Article - Benefits

01. Benefit Options

Each Participant may elect to have his or her full compensation paid to him in taxable compensation or elect to have the amount of his or her Salary Redirection amounts applied to any one or more of the optional Benefits or any other group-insured or self-funded Benefit permitted under Code Section 125, that is offered by the Employer as set forth in the Adoption Agreement.

The Employer may select suitable health and hospitalization Insurance Contracts for use in providing health Benefits, which policies will provide uniform benefits for all Participants electing this Benefit.

02. Description of Benefits

Each Eligible Employee may elect to have the Administrator pay those contributions that the Employee is required to make to the Benefit options described under the Section titled: "Benefit Options", as a condition for the Employee and his or her Dependents to participate in those Benefit options.

03. Nondiscrimination Requirements

(a) It is the intent of this Plan to provide benefits to a classification of Employees that the Secretary of the Treasury finds not to be discriminatory in favor of the group in whose favor discrimination is prohibited under Code Section 125 or applicable Regulations thereunder.

(b) If the Administrator deems it necessary, in order, to avoid discrimination or possible taxation to Highly Compensated Employees, Key Employees or a group of employees in whose favor discrimination is prohibited by Code Section 125, it may, but shall not be required to, reduce contributions or non-taxable Benefits in order to assure compliance with this section. Any act taken by the Administrator under this section shall be carried out in a uniform and nondiscriminatory manner. If the Administrator decides to reduce contributions or non-taxable Benefits, it shall be done in the following manner. First, the non-taxable Benefits of the affected Participant (either an employee who is highly compensated or a Key Employee, whichever is applicable) who has the highest amount of non-taxable Benefits for the Plan Year shall have his or her non-taxable benefits reduced until the discrimination tests set forth in this Section are satisfied or until the amount of his or her non-taxable Benefits equals the non-taxable Benefits of the affected Participant who has the second highest amount of non-taxable Benefits. This process shall continue until the nondiscrimination tests set forth in this Section are satisfied. With respect to any affected Participant who has had Benefits reduced pursuant to this Section, the reduction shall be made proportionately among all insured Benefits. Contributions which are not utilized to provide Benefits to any Participant by virtue of any administrative act under this paragraph shall be forfeited and deposited into the Plan surplus.

04. Non-Tax Dependent Coverage

- a. If (i) Employee Salary Redirections are made to fund Benefits under the Plan, and (ii) the Employer allows a Participant to elect to cover a Non-Tax Dependent through the Participant's coverage under group Medical, Dental or Vision benefit(s), a Participant who elects to participate in the Salary Redirection program may pay on a pre-tax basis through salary reduction contributions the Participant's portion of the premium cost of coverage under the Employer's Medical, Dental or Vision Benefits, provided that the full fair market value of such Medical, Dental or Vision coverage for any such Non-Tax Dependent shall be includible in the Participant's gross income as a taxable benefit in accordance with applicable federal income tax rules. For purposes of this Plan, the Participant electing coverage for Non-Tax Dependent(s) shall be treated as receiving, at the time that coverage is received, cash compensation equal to the full fair market value of such coverage and then as having purchased the coverage with after-tax employee contributions.
- b. Notwithstanding the foregoing, no medical care or dependent care expenses incurred by or with respect to a Non-Tax Dependent of a Participant shall be eligible for reimbursement as eligible expenses under the Health Flexible Spending Account or Dependent Care Flexible Spending Account.

V. Article - Participant Elections

01. Initial Elections

An Employee who meets the Eligibility Requirements of the Plan on the first day of, or during, a Plan Year may elect to participate in this Plan for all or the remainder of such Plan Year, provided he or she elects to do so before his or her effective date of participation pursuant to the Section titled: "Effective Date of Participation". or for a newly eligible Employee, no more than 30 days after their date of hire. For any such newly Eligible Employee, if coverage is effective as of the date of hire, such Employee shall be eligible to participate retroactively as of their date of hire. Newly Eligible Employee Election amounts will be collected the first pay period on or after his or her election was received. However, if such Employee does not complete an application to participate and a benefit election form and deliver them to the Administrator before such date, his or her Election Period shall extend 30 calendar days after such date, or for such further period as the Administrator shall determine and apply on a uniform and nondiscriminatory basis. However, any election during the extended 30-day election period pursuant to this Section shall not be effective until the first pay period following the later of such Participant's effective date of participation pursuant to the Section titled: "Effective Date of Participation" or the date of the receipt of the election form by the Administrator, and shall be limited to the Benefit expenses incurred for the balance of the Plan Year for which the election is made. Any failure to elect the Benefits set forth herein shall constitute an Employee's election to not participate in the Plan during that Plan Year until a valid election is otherwise made in the manner set forth herein.

02. Subsequent Annual Elections

- a. A Participant will automatically be enrolled in subsequent plan years unless the Participant terminates his or her participation in the Plan by notifying the Administrator in writing during the Election Period that he or she does not want to participate in the Plan for the next Plan Year;
- b. A Participant may terminate his or her participation in the Plan by notifying the Administrator in writing during the Election Period that he or she does not want to participate in the Plan for the next Plan Year;
- c. An Employee who elects to not participate for the Plan Year following the Election Period will have to wait until the next Election Period before again electing to participate in the Plan, except as provided for in the Section titled: "Change of Elections".

03. Change of Elections

- a. Any Participant may change a Benefit election after the Plan Year has commenced and make new elections with respect to the remainder of such Plan Year if, under the facts and circumstances, the changes are necessitated by and are consistent with a change in status that is recognized under rules and regulations adopted by the Department of the Treasury. Notwithstanding anything herein to the contrary, if the rules and regulations conflict with provisions of this Plan, then such rules and regulations shall control.

In general, a change in election is not consistent if the change in status is the Participant's divorce, annulment or legal separation from a spouse, the death of a spouse or dependent, or a dependent ceasing to satisfy the Eligibility Requirements for coverage, and the Participant's election under the Plan is to cancel accident or health insurance coverage for any individual other than the one involved in such an event. In addition, if the Participant, spouse or dependent gains or loses eligibility for coverage under a family member's plan as a result of a change in marital status or a change in employment status, then a Participant's election under the Plan to cease or decrease coverage for that individual under the Plan is consistent with that change in status only if coverage for that individual becomes applicable or is increased under the family member's plan.

Regardless of the consistency requirement, if the individual, the individual's spouse, or dependent, becomes eligible for continuation coverage under the Employer's group health plan as provided in Code Section 4980B or any similar state law, then the individual may elect to increase payments under this Plan in order to pay for the continuation coverage. However, this does not apply for COBRA eligibility due to divorce, annulment or legal separation.

Any new election shall be effective at such time as the Administrator shall prescribe, but not earlier than the first pay period beginning after the election form is completed and returned to the Administrator. For the purposes of this subsection, a change in status shall only include the following events or other events permitted by Treasury regulations:

1. Legal Marital Status: events that change a Participant's legal marital status, including marriage, divorce, death of a spouse, legal separation or annulment;
2. Number of Dependents: Events that change a Participant's number of dependents,

including birth, adoption, placement for adoption, or death of a dependent;

3. Employment Status: Any of the following events that change the employment status of the Participant, spouse, or dependent: termination or commencement of employment, a strike or lockout, commencement of return from an unpaid leave of absence, or a change in worksite. In addition, if the eligibility conditions of this Plan or another employee benefit plan of the employer of the spouse, or dependent, depend on the employment status of that individual and there is a change in that individual's employment status with the consequence that the individual becomes (or ceases to be) eligible under the applicable plan, then that change constitutes a change in employment under this subsection;
 4. Dependent satisfies or ceases to satisfy the Eligibility Requirements: an event that causes the Participant's dependent to satisfy or cease to satisfy the requirements for coverage due to attainment of age, student status, or any similar circumstance; and
 5. Residency: A change in the place of residence of the Participant, spouse or dependent.
- b. Notwithstanding subsection (a), affected Participants may change an election for accident or health coverage during a Plan Year and make a new election in accordance with the special enrollment rights provided in Code Section 9801(f) pertaining to HIPAA special enrollment rights or the Family and Medical Leave Act.

An affected Participant may change an election for accident or health coverage during a Plan Year and make a new election in accordance with the special enrollment rights provided in Code Section 9801(f), including those authorized under the provisions of the Children's Health Insurance Program Reauthorization Act of 2009 (CHIP); provided that such Participant meets the sixty (60) day notice requirement imposed by Code Section 9801(f) (or such longer period as may be permitted by the Plan and communicated to Participants).

Such change shall take place on a prospective basis, unless required by Code Section 9801(f) to be retroactive.

- c. Notwithstanding subsection (a), in the event of a judgment, decree, or order ("order") resulting from a divorce, legal separation, annulment, or change in legal custody (including a qualified medical child support order defined in ERISA Section 609) that requires accident or health coverage for a Participant's child (including a foster child who is a dependent of the Participant):
1. The Plan may change an election in order to provide coverage for the child if the order requires coverage under the Participant's plan; or
 2. The Participant shall be permitted to change an election in order to cancel coverage for the child if the order requires the former spouse to provide coverage for such child, under that individual's plan, and such coverage is actually provided.
- d. Notwithstanding subsection (a), Participants may change elections in order to cancel accident or health coverage for the Participant or the Participant's spouse or dependent if the Participant or the Participant's spouse or dependent is enrolled in the accident or health coverage of the Employer and becomes entitled to coverage (i.e., enrolled) under Part A or Part B of the Title XVIII of the Social Security Act (Medicare) or Title XIX of the Social Security Act (Medicaid), other than coverage consisting solely of benefits under section 1928 of the Social Security Act (the program for distribution of pediatric vaccines). If the Participant or the Participant's spouse or dependent who has been entitled to Medicaid or Medicare coverage loses such eligibility, that individual may prospectively elect coverage under the Plan if a benefit package option under the Plan provides similar coverage.
- e. Notwithstanding subsection (a), Participants may make a prospective election change to add group health coverage for the Participant or the Participant's spouse or dependent if the Participant or the Participant's spouse or dependent loses coverage under any group health coverage sponsored by a governmental or educational institution, including (but not limited to) the following: a state children's health insurance program (CHIP) under Title XXI of the Social Security Act; a medical care program of an Indian Tribal government (as defined in Code Section 7701 (a) (40)), the Indian Health Service, or a tribal organization; a state health benefits risk pool; or a foreign government group health plan, subject to the terms and limitations of the applicable benefit package option(s).
- Further, if the Participant or the Participant's spouse or dependent who has been entitled to Medicare or Medicaid loses eligibility for such coverage, the Participant may elect to prospectively commence or increase the accident or health coverage of the individual who loses Medicare or Medicaid eligibility.
- f. Notwithstanding subsection (a), a Participant may prospectively revoke his or her election of group health plan coverage if (i) the Participant changes from full-time employment (i.e., at least 30 hours of service per week) to part-time employment (i.e., less than 30 hours of

service per week), even if the Participant continues to be eligible for coverage under the group health plan, and (ii) the Participant, and any related individuals whose coverage is also to be revoked, intend to enroll in another plan that provides minimum essential coverage and is effective no later than the first day of the second month after the month during which the revocation is effective.

- g. Notwithstanding subsection (a), a Participant may prospectively revoke his or her election of group health plan coverage if (i) the Participant is eligible for a Special Enrollment Period to enroll in a Qualified Health Plan through a Marketplace, or seeks to enroll in a Qualified Health Plan through a Marketplace during the Marketplace's annual open enrollment period, and (ii) the Participant, and any related individuals whose coverage is also to be revoked, intend to enroll in a Qualified Health Plan through a Marketplace that is effective no later than the day immediately following the effective date of the revocation.
- h. Notwithstanding subsection (a), if the cost of a Benefit provided under the Plan increases or decreases during a Plan Year, then the Plan shall automatically increase or decrease, as the case may be, the Salary Redirections of all affected Participants for such Benefit. Alternatively, if the cost of a benefit package option increases significantly, the Administrator shall permit the affected Participants to either make corresponding changes in their payments or revoke their elections and, in lieu thereof, receive on a prospective basis coverage under another benefit package option with similar coverage; or drop coverage prospectively if there is no other benefit package option available that provides similar coverage. This Plan treats coverage by another employer, such as a spouse's or dependent's employer, as similar coverage.

A cost increase or decrease refers to an increase or decrease in the amount of elective contributions under the Plan, whether resulting from an action taken by the Participants, an action taken by the Employer, or an action taken by an Insurer.

- i. Notwithstanding subsection (a), if the cost of a Benefit package option provided under the plan decreases significantly during a Plan Year, the Administrator shall permit the affected Participants to make corresponding changes in their payments; and employees who are otherwise eligible under the Plan may elect the Benefit package option, subject to the terms and limitations of the Benefit package option.

If the coverage under a Benefit is significantly curtailed, and such curtailment results in a complete loss of coverage, affected Participants may revoke their elections of such Benefit and, in lieu thereof, elect to receive on a prospective basis coverage under another plan with similar coverage, or drop coverage prospectively if there is no other Benefit package option available that provides similar coverage.

If the coverage under a Benefit is significantly curtailed, and such curtailment does not result in a loss of coverage, affected Participants may revoke their elections of such Benefit and, in lieu thereof, elect to receive on a prospective basis coverage under another plan with similar coverage.

If, during the period of coverage, a new Benefit package option or other coverage option is added (or an existing Benefit package option or other coverage option is eliminated) or a significantly improved existing Benefit package option is added, then the affected Participants and employees who are otherwise eligible under the Plan may elect the newly-added or significantly improved option (or elect another option if an option has been eliminated) prospectively and make corresponding election changes with respect to other Benefit package options providing similar coverage.

- j. Notwithstanding subsection (a), a Participant may make a prospective election change to add group health coverage for the Participant, or the Participant's Spouse or Dependent, if such individual loses group health coverage under a governmental or educational institution, including a state children's health insurance program under the Social Security Act, the Indian Health Service or a health program offered by an Indian tribal government, a state health benefits risk pool, or a foreign government group health plan.

VI. Article - Administration

01. Plan Administration

The Employer shall be the Administrator, unless the Employer elects otherwise. The Employer may appoint any person or persons, including, but not limited to, one or more Employees of the Employer, to perform the duties of the Administrator. Any person so appointed shall signify acceptance by filing written acceptance with the Employer. An Administrator may resign by delivering a written resignation to the Employer, to take effect at a date specified therein, or upon delivery to the Employer if no date is specified. The Administrator may be removed by the Employer by delivering a written notice of removal to the Administrator, to take effect at a date specified therein, or upon delivery to the Administrator if no date is specified. Upon the resignation or removal of any individual performing the duties of the Administrator, the Employer may designate a successor.

The operation of the Plan shall be under the supervision of the Administrator. It shall be a principal duty of the Administrator to see that the Plan is carried out in accordance with its terms, and for the exclusive benefit of Employees entitled to participate in the Plan. The Administrator shall have full power to administer the Plan in all of its details, subject, however, to the pertinent provisions of the Code. The Administrator's powers shall include, but shall not be limited to the following authority, in addition to all other powers provided by this Plan:

- a. To make and enforce such rules and regulations as the Administrator deems necessary or proper for the efficient administration of the Plan;
- b. To interpret the Plan, the Administrator's interpretations thereof in good faith to be final and conclusive on all persons claiming benefits by operation of the Plan;
- c. To decide all questions concerning the Plan and the eligibility of any person to participate in the Plan and to receive benefits provided under the Plan;
- d. To reject elections or to limit contributions or Benefits for certain Highly Compensated Participants if it deems such to be desirable in order to avoid discrimination under the Plan in violation of applicable provisions of the Code;
- e. To provide Employees with a reasonable notification of their benefits available under the Plan;
- f. To keep and maintain the Plan documents and all other records pertaining to and necessary for the administration of the Plan;
- g. To keep and communicate procedures to determine whether a medical child support order is qualified under ERISA Section 609; and
- h. To appoint such agents, counsel, accountants, consultants, and actuaries as may be required to assist in administering the Plan.

Any procedure, discretionary act, interpretation or construction taken by the Administrator shall be done in a nondiscriminatory manner based upon uniform principles consistently applied and shall be consistent with the intent that the Plan shall continue to comply with the terms of Code Section 125 and the Treasury regulations thereunder.

02. Examination of Records

The Administrator shall make available to each Participant, Eligible Employee and any other Employee of the Employer such records as pertain to their respective interests under the Plan for examination at reasonable times during normal business hours.

03. Payment of Expenses

Any reasonable administrative expenses shall be paid by the Employer unless the Employer determines that administrative costs shall be borne by the Participants under the Plan or by any Trust Fund which may be established hereunder. The Administrator may impose reasonable conditions for payments, provided that such conditions shall not discriminate in favor of Highly Compensated Employees.

04. Application of Benefit Plan Surplus

Any forfeited amounts credited to the Benefit Plan surplus by virtue of the failure of a Participant to incur a qualified expense may, but need not be, separately accounted for after the close of the Plan Year in which such forfeitures arose. In no event shall such amounts be carried over to reimburse a Participant for expenses incurred during a subsequent Plan Year for the same or any other Benefit available under the Plan; nor shall amounts forfeited by a particular Participant be made available to such Participant in any other form or manner, except as permitted by Treasury

regulations. Amounts in the Benefit Plan surplus shall first be used to defray any administrative costs and experience losses and thereafter be retained by the Employer.

05. **Insurance Control Clause**

In the event of a conflict between the terms of this Plan and the terms of an Insurance Contract of a particular Insurer or other benefit program that is self-insured whose product is then being used in conjunction with this Plan, the terms of the Insurance Contract shall control as to those Participants receiving coverage under such Insurance Contract. For this purpose, the Insurance Contract shall control in defining the persons eligible for insurance, the dates of their eligibility, the conditions which must be satisfied to become insured, if any, the Benefits Participants are entitled to and the circumstances under which insurance terminates.

06. **Indemnification of Administrator**

The Employer agrees to indemnify and to defend to the fullest extent permitted by law any Employee serving as the Administrator or as a member of a committee designated as Administrator (including any Employee or former Employee who previously served as Administrator or as a member of such committee) against all liabilities, damages, costs and expenses (including attorney's fees and amounts paid in settlement of any claims approved by the Employer) occasioned by any act or omission to act in connection with the Plan, if such act or omission is in good faith.

VII. Article - Amendment or Termination of Plan

01. Amendment

The Employer, at any time or from time to time, may amend any or all of the provisions of the Plan without the consent of any Employee or Participant. No amendment shall have the effect of modifying any benefit election of any Participant in effect at the time of such amendment, unless such amendment is made to comply with federal, state or local laws, statutes or regulations.

02. Termination

The Employer is establishing this Plan with the intent that it will be maintained for an indefinite period of time. Notwithstanding the foregoing, the Employer reserves the right to terminate the Plan, in whole or in part, at any time. In the event the Plan is terminated, no further contributions shall be made. Benefits under any Insurance Contract shall be paid in accordance with the terms of the Contract.

Any amounts remaining in any such fund or account as of the end of the Plan Year in which Plan termination occurs shall be forfeited and deposited in the Benefit Plan surplus.

VIII. Article - Miscellaneous

01. Plan Interpretation

All provisions of this Plan shall be governed and interpreted by the Employer, or its delegated Administrator, as applicable, in its full and complete discretion and shall be otherwise applied in a uniform, nondiscriminatory manner. This Plan shall be read in its entirety and not severed except as provided in the Section titled: "Severability".

02. Gender and Number

Wherever any words are used herein in the masculine, or feminine, or are gender neutral, they shall be construed as though they were also used in another gender in all cases where they would so apply, and whenever any words are used herein in the singular or plural form, they shall be construed as though they were also used in the other form in all cases where they would so apply.

03. Written Document

This Plan document, in conjunction with any separate written document which may be required by law, is intended to satisfy the written Plan requirement of Code Section 125 and any Regulations thereunder relating to Cafeteria Plans.

04. Exclusive Benefit

This Plan shall be maintained for the exclusive benefit of the Employees who participate in the Plan.

05. Participant's Rights

This Plan shall not be deemed to constitute an employment contract between the Employer and any Participant or to be a consideration or an inducement for the employment of any Participant or Employee. Nothing contained in this Plan shall be deemed (i) to give any Participant, or (ii) Employee the right to be retained in the service of the Employer or to interfere with the right of the Employer to discharge any Participant or Employee at any time regardless of the effect which such discharge shall have upon him as a Participant of this Plan.

06. Action by the Employer

Whenever under the terms of the Plan the Employer is permitted or required to do or perform any act or matter or thing, it shall be done and performed by a person duly authorized by the Employer to do so.

07. Employer's Protective Clauses

- a. Upon the failure of the Employer to obtain the insurance contemplated by this Plan (whether as a result of negligence, gross neglect or otherwise), a Participant's Benefits shall be limited to the insurance premium(s), if any, that remained unpaid for the period in question and the actual insurance proceeds, if any, received by the Employer or the Participant as a result of the Participant's claim.
- b. The Employer's liability to a Participant shall only extend to and shall be limited to any payment actually received by the Employer from the Insurer. In the event that the full insurance Benefit contemplated is not promptly received by the Employer within a reasonable time after submission of a claim, then the Employer shall notify the Participant of such facts and the Employer shall no longer have any legal obligation whatsoever (except to execute any document called for by a settlement reached by the Participant). The Participant shall be free to settle, compromise or refuse the claim as the Participant, in his or her sole discretion, shall see fit.
- c. The Employer shall not be responsible for the validity of any Insurance Contract issued hereunder or for the failure on the part of the Insurer to make payments provided for under any Insurance Contract. Once insurance is applied for or obtained, the Employer shall not be liable for any loss which may result from the failure to pay Premiums to the extent Premium notices are not received by the Employer.

08. No Guarantee of Tax Consequences

Neither the Administrator nor the Employer makes any commitment or guarantee that any amounts paid to or for the benefit of a Participant under the Plan will be excludable from the Participant's gross income for federal or state income tax purposes, or that any other federal or state tax treatment will apply to or be available to any Participant. Notwithstanding the foregoing, the rights of Participants under this Plan shall be legally enforceable.

09. Indemnification of Employer by Participants

If any Participant receives one or more payments or reimbursements under the Plan that are not for a permitted Benefit, such Participant shall indemnify and reimburse the Employer for any liability it may incur for failure to withhold federal or state income tax or Social Security tax from such payments or reimbursements. However, such indemnification and reimbursement shall not exceed the amount of additional federal and state income tax that the Participant would have owed if the payments or reimbursements had been made to the Participant as regular cash compensation, plus the Participant's share of any Social Security tax that would have been paid on such compensation, less any such additional income and Social Security tax actually paid by the Participant.

10. **Funding**

Unless otherwise required by law, contributions to the Plan need not be placed in trust or dedicated to a specific Benefit, but shall instead be considered general assets of the Employer until the Premium Expense required under the Plan has been paid. Furthermore, and unless otherwise required by law, nothing herein shall be construed to require the Employer or the Administrator to maintain any fund or segregate any amount for the benefit of any Participant, and no Participant or other person shall have any claim against, right to, or security or other interest in, any fund, account or asset of the Employer from which any payment under the Plan may be made.

11. **Governing Law**

This Plan is governed by the Code and the Treasury regulations issued thereunder (as they might be amended from time to time). In no event does the Employer guarantee the favorable tax treatment sought by this Plan. To the extent not preempted by federal law, the provisions of this Plan shall be construed, enforced and administered according to the laws of the state of California.

12. **Severability**

If any provision of the Plan is held invalid or unenforceable, its invalidity or unenforceability shall not affect any other provisions of the Plan, and the Plan shall be construed and enforced as if such provision had not been included herein.

13. **Captions**

The captions contained herein are inserted only as a matter of convenience and for reference, and in no way define, limit, enlarge, or describe the scope or intent of the Plan, nor in any way shall they affect the Plan or the construction of any provision thereof.

14. **Continuation of Coverage**

Notwithstanding anything in the Plan to the contrary, in the event any benefit under this Plan subject to the continuation coverage requirement of Code Section 4980B becomes unavailable, each Participant will be entitled to continuation coverage as prescribed in Code Section 4980B.

15. **Health Insurance Portability and Accountability Act**

Notwithstanding anything in this Plan to the contrary, this Plan shall be operated in accordance with HIPAA and regulations thereunder.

16. **Uniformed Services Employment and Reemployment Rights Act**

Notwithstanding any provision of this Plan to the contrary, contributions, benefits and service credit with respect to qualified military service shall be provided in accordance with USERRA and the regulations thereunder, as well as any other applicable Regulations specific to the rights and obligations of Employers with Employees on active military leave.

17. **Genetic Information Nondiscrimination Act**

Notwithstanding any provision of this Plan to the contrary, this Plan shall be operated in accordance with GINA and regulations thereunder.
