

# Community Fund for Carmel Valley Better Together – Helping Carmel Valley Thrive Homeowner & Renter Program – 2023 Floods

The Community Fund for Carmel Valley of the Community Foundation is accepting applications from Monterey County homeowners and renters whose primary residence in the Carmel Valley area was damaged by the 2023 atmospheric river and related flooding events. Please read this overview before completing the application.

#### What assistance is available?

Direct financial assistance is available to qualified applicants in amounts ranging from \$500 to \$1,500 per household for Homeowners and Renters as a one-time payment. Consideration for additional assistance will be made as funding is available.

#### How can I use the funds, if awarded?

You may use the funds awarded to replace contents and make repairs to your home. You may also use funds to cover essential living expenses, such as temporary housing (for example, paying for temporary housing during repairs), replacing an automobile or replacing work tools or equipment.

#### What are the eligibility requirements?

To qualify for direct financial assistance, you must meet the following criteria:

 Your primary residence in the Carmel Valley area of Monterey County was damaged due to the 2023 atmospheric river storms and related flooding events.

### What documents do I need to be considered to receive assistance?

- A completed application (see the following pages).
- Photo identification. A current copy of any one of the following may be used: state issued driver license or identification card; Real ID; or passport;
- Proof of homeownership/primary residence. A recent copy of any one of the following may be used: utility bill; lease/rental agreement; mortgage statement; property tax statement.
- If you are a renter, the name and contact information for your landlord or leaseholder.
- Additional documentation may be requested at the Community Foundation's discretion.

## What is the deadline to apply?

Your application will be treated as *CONFIDENTIAL* and will only be used by the Community Foundation to determine needs and recommend grant funding. Funding will be awarded as available. #### Where to Send Your Completed Application

All applications will be reviewed by board members of the Community Fund for Carmel Valley. Funding will be distributed by Rotary, a nonprofit organization based in Monterey County with significant experience in distributing direct financial assistance after disasters. Funding is provided by Community Fund for Carmel Valley, which is managed by Community Foundation for Monterey County, a separate nonprofit organization based in Monterey County. The Community Fund for Carmel Valley administer this program and approve all grant recipients. Decisions are made in accordance with relevant federal and state laws and regulations and are communicated to applicants by email or phone. Individuals may submit an application through email, mail or online. Applicants can expect to receive a response by late March/early April. Approval timing is based on collection of all required documentation.
