# COMMUNITY FOUNDATION FOR MONTEREY COUNTY NOTES TO THE FINANCIAL STATEMENTS For the Six Months Ended June 30, 2015

#### **Assets**

Total Assets through 6/30/2015 are \$183,334,413 a 1.80% increase since June 2014, and a 2.24% increase since December 2014. (p. 3)

### Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third party account balances as of December 31, 2014. (p. 3)

#### Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$8,500, and unrealized gains were \$748,281, for a total gain of \$756,781. (p. 6)

#### **Operating Fund**

Total revenue was \$6,930 less than the budget, and total expenses were \$107,205 less than the budget. The actual net operating surplus is \$158,654 compared to a budgeted surplus of \$100,275. (p. 7)

Note: The Expendable Operating Cash-on-Hand is at 6.9 months, excluding the operating reserve of \$250,000 and the building reserve of \$125,000. (p. 8)

### Portfolio Performance

The market value of the portfolio at 6/30/2015 was \$147,545,454. The Total Return for the year to date Pooled Endowment Portfolio through June 30, 2015 was 1.8% compared to the Policy Index of 1.4%. (p. 9-12)

### **Special Program Funds**

Special Program Funds include: Community Leadership Project – funded by the David and Lucile Packard Foundation; Pathways to Safety – funded by the ACTION Council of Monterey County; Girl's Health in Girl's Hands, funded by the Claire Giannini Fund, the Peggy and Jack Baskin Foundation, the David and Lucile Packard Foundation and the Monterey Peninsula Foundation; and the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation.

Total Special Program revenue was \$562,201 and total expenses were \$132,100. (p. 5-6)

### Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$1,501,126, including \$60,000 from Chamber Music Monterey Bay for the Chamber Music Monterey Bay Stewardship Fund: \$354,907 from the Scottish Fiddlers of California to establish the Learning Opportunities Endowment Fund for Scottish Fiddlers of California; and a \$50,000 grant from the College Futures Foundation for the Operating Fund, to pay for a feasibility assessment of a strategic scholarships program. (p. 15-23)

Grants to agencies for the month totaling \$529,336 were approved and recorded. A complete list of the grants by grantee is included. (p. 24-25)

Interfund activity for the month totaled \$30,400. (p. 23 & 25)

#### Bequests Receivable

We recorded a beguest receivable for the Farrell/Allen Carmel Rotary Fund, in the amount of \$958,528, from the estate of Richard W. LaSalle, which represents 75% of the appraised value of the home located in Carmel.

### **Prior Period Note**

In May, we received payment on a receivable from the Monterey Peninsula Foundation, in the amount of \$100,000, for The Monterey Experience Project Fund.




